Gary pointed out we can not enforce modesty and there is no way to enforce suit policies once the swimmers are on the blocks. There was a discussion about Northern Area team affiliated teams are age group events with all swimmers under the age of 18, and that the concern is for the safety of the swimmers. There is also the issue of keeping the meets age and gender friendly by eliminating the uncomfortable scenario of what is being viewed and talked about in the stands during the meets.
