High School Observation Request Guidelines Form A (Non-Season Culminating Championship Meet) For Consideration by Alaska Swimming

High School times <u>may</u> be accepted from a Non-Season Culminating Championship Meet if the following requirements are met. These requirements are to provide Alaska Swimming Athlete Members an opportunity to achieve times in the SWIMS database, while also reducing the workload on Alaska Swimming Volunteers. Each observed meet must be carefully reviewed by multiple Alaska Swimming volunteers, and these guidelines will aid a smooth, successful process. More information can be found in the <u>USA Swimming Rulebook Article</u> 202.8. Questions should be sent to one of the Alaska Swimming volunteers below.

Pre-Meet Guidelines

- 1. Complete Form A below and submit to Patrick Burda at least 10 days prior to the meet.
- 2. Enter USA Swimming ID # for each USA Swimming Registered Athlete ONLY. DO NOT enter USAS ID # for non-USAS Registered Athletes.
 - a. MM > Athletes > double click athlete > enter Reg ID #
- 3. Submit a registration recon to Angela Heaphy at least 3 days prior to the meet. ONLY INCLUDE athletes with a USAS ID #.
 - a. MM > File > Export > USA-S Registration > check 'Only Include Athletes with a USS ID'

Post-Meet Guidelines

- 1. Ensure all information for each USAS Registered Athlete is correct.
- 2. Export results for USAS Registered Athletes ONLY.
 - a. MM > File > Export > Results for Swim Manager or SWIMS or NCAA or USMS > check 'Only Include Athletes with a USS ID'
- 3. Submit results file to Patrick Burda.

Please Note

- Flagged results during the 'SWIMS Exception Report' WILL be deleted. It is the coach's responsibility to ensure all information is correct for each USAS Registered Athlete.
- Submitted results which include Non-USAS Registered Athletes may void results for the entire meet. DO NOT SUBMIT RESULTS FOR NON-USAS REGISTERED ATHLETES.
- **USAS** will not approve observations for Dual Meets or Time Trials. Meets must have a minimum of three participating teams to be considered for observation (invitational).
- USAS will not approve meets that do not follow the NFHS High School Event Order.

The LSC official will send this completed form to the Program Operations Vice President or designee for approval. The request must include a reason & explanation for the request.

Acceptance of verification requests from the meet is subject to proof that conditions at the meet were in conformance with the required procedures and pertinent USA Swimming Rules and Regulations.
