## Dues Payment Policy Scottsdale Aquatic Club, Inc., a 501(c)(3) Charity

## Approved by Board of Directors on July 14, 2023

SAC is a year-round program with year-round commitments to our coaching staff, vendors and the City of Scottsdale. By joining SAC, families are making an annual financial commitment with their dues (USA Swimming Seasonal Year from Sept 1st to August 31st). In order to maintain our club's operations, we expect that SAC families continue to pay their dues on a monthly basis in order to maintain their position on the team.

Effective September 1, 2023, families will have two membership options with SAC for their swimmer(s): **Annual Membership** and **Semi-Annual Membership**. The requirements for each membership level are outlined below and a monthly dues summary is provided. The below membership terms are in addition to SAC's *Service Hours Policy* and *Fundraising Policy* which are required of all SAC families and can be found on SAC's website.

Please note: The Annual Membership commitment maintains the current dues and does not change the total amount a family pays.

Families who select the <u>Annual Membership</u> for their swimmer(s) are committing to 12-months of dues and will continue to pay monthly dues based on the published Dues schedule for their swimmer's respective practice group for the entire membership period. The membership period begins on September 1<sup>st</sup> and ends on August 31<sup>st</sup>. Monthly dues will be charged on the 1<sup>st</sup> of each month. Annual Memberships will automatically renew on September 1<sup>st</sup> of each year unless written communication is received 60 days prior to the end of the membership period stating your request to cancel your Annual Membership and prevent automatic renewal for the next season. CANCELATION CLAUSE - If a family chooses to end their swimmer(s)' commitment prior to August 31<sup>st</sup>, they are responsible for the balance of dues owed through the end of the membership period (August 31<sup>st</sup>) and will be billed for the remaining balance at the time SAC receives notice of cancellation. In addition, families must be current with both the annual service hour commitment and annual fundraising commitment per the terms of SAC's *Service Hours Policy* and *Fundraising Policy* or the family will be billed for any short-fall per said policies at the time of notice of cancellation.

Families who select the <u>Semi-Annual Membership</u> for their swimmer(s) are committing to 6-months of dues, following an adjusted dues structure for their swimmer's respective practice group. The membership periods are defined as September 1<sup>st</sup> – February 28<sup>th</sup>, and March 1<sup>st</sup> – August 31<sup>st</sup>. Monthly dues will be charged on the 1<sup>st</sup> of each month during your membership period. Semi-Annual Memberships automatically renews on the first day of the next semi-annual membership period unless written communication is received 60 days prior to the end of the current semi-annual membership period stating your request to cancel your Semi-Annual Membership and prevent automatic renewal for the next semi-annual period. CANCELATION CLAUSE - If a family chooses to end their commitment prior to the end of their semi-annual membership period and will be billed for the remaining balance at the time SAC receives notice of cancellation. In addition, families must be current with both their service hour

commitment and fundraising commitment per the terms of SAC's *Service Hours Policy* and *Fundraising Policy* or the family will be billed for any short-fall per said policies at the time of notice of cancellation.

Additional Information: Swimmers who join SAC after September 1<sup>st</sup> will be eligible to enroll in either Annual or Semi-Annual Membership levels and will be billed for monthly dues from the 1<sup>st</sup> month of enrollment through the end of their selected Membership Period, subject to the automatic renewal clause stated above in your respective Membership group. Families will have the opportunity to change their swimmer(s)' Membership level to/from Annual to/from Semi-Annual effective September 1<sup>st</sup> of each year by notifying SAC in writing 60 days prior to the September 1<sup>st</sup> effective date. No mid-year changes to Membership levels will be available.

<u>Graduating Seniors</u> – For swimmers enrolled in the Annual Membership who graduate high school during their membership period, SAC agrees to waive the monthly dues obligation for any months between June 1<sup>st</sup> and August 31<sup>st</sup> for which proper cancellation notice is provided to SAC per the membership's cancellation terms.
