



## **GMSC ENROLLMENT POLICIES**

### **MONTHLY MEMBERSHIP FEES:**

GMSC families are making an annual financial commitment with their monthly dues (swimming year from Sept 1st to August 31st). GMSC families continue to pay their dues on a monthly basis in order to maintain their position on the team. Extended breaks in enrollment must be approved in advance by GMSC coaching staff.

Monthly membership fees are billed on the first of every month using the credit card on file on Team Unify. Monthly membership fees are calculated based on which group the swimmer trains with and includes credit card processing fees. Monthly membership fees do not include applicable tax.

Accounts which are delinquent after the third of the month will be notified via email and/or phone call weekly for up to four weeks. After the fourth week, swimmers with delinquent accounts will be held out of practice until the balance has been paid in full.

GMSC does not offer discounts on tuition including sibling discounts.

### **USA SWIMMING REGISTRATION:**

To be a member of GMSC, every swimmer must be a USA Swimming registered swimmer. This membership covers the swimmer with liability insurance while at practice, organized events, and swim meets.

All USA Swimming registrations and renewals are done directly through the USA Swimming website. Every swimmer must have an active membership with USA Swimming to participate in practice, meets, and team events.

### **ANNUAL REGISTRATION FEE:**

The GMSC annual registration fee is automatically charged yearly on October 1st for continuing athletes or upon registration for new or returning athletes. The annual registration fee is currently \$150 for the 2023-24 season. The annual registration fee is non-refundable.

### **MEET FEES:**

Swimmers are responsible for paying entry fees for swim meets they attend. For USA Swimming sanctioned meets, there is an individual event fee plus a LSC surcharge for per swimmer. Individual



event fees range from \$3 to \$7.50 per event depending on the type of meet (non-time standard, A-B-C meet, or championship meets). The current AZ Swimming LSC fee is \$8.00 per swimmer. All relay fees are paid by the swimmers participating on the relays.

Coaches will have expenses related to travel, food, and possibly accommodations paid for at every meet GMSC attends. Each swimmer attending the meet will be billed a pro-rated amount of the total overall coaching expenses.

Coaches are reimbursed for mileage, daily per diem, and accommodations. Mileage is calculated from Gold Medal Swim School to the swim meet driven at .56 per mile. Meals are calculated as follows- \$45 for the day. \$11 for breakfast, \$12 for lunch, and \$22 for dinner.

All fees will be charged to the credit card on file with the Gold Medal Swim School on the 18<sup>th</sup> of every month. A breakdown of meet fees, travel expenses, and coach's per diem will be sent to families seven days before charges are made. Families are responsible to contact the club admin with any questions or concerns before the 18<sup>th</sup> when charges occur.

**CANCELLATION:**

A thirty day notice and a meeting with the swimmer's coach is required to withdraw from Gold Medal Swim Club. Cancellations are accepted through the [Cancellation Request](http://www.goldmedalswimschool.com) form via the Gold Medal Swim School website ([www.goldmedalswimschool.com](http://www.goldmedalswimschool.com) ><Members tab>Cancellation Request).
