OPENING

APPROVAL OF AGENDA

Savona made a motion to approve the agenda and Scott seconded the motion. The agenda was unanimously approved.

APPROVAL OF MINUTES

Justin approved the June minutes and Corry seconded it. Corry asked Savona to forward on to Patty Ray (web master) the reports referenced in the June minutes. Upon review of the bylaws, the applicable reports will be individually forwarded to Savona, and Savona will then follow up with Patty.

COACH'S REPORT (PRESENTED BY COACH SCOTT)

- Scott shared that 6 swimmers are planning to attend long course champs (last week of July).
- The board reviewed the proposed fall GSC schedule. It was clarified that with respect to the Orca group, that TM swimmers will have the opportunity to attend GSC practices at DPAC twice a week on Tuesday's and Thursday's from 5-6:30pm, and that JD swimmers will have the opportunity to attend GSC practices at AGB Pool twice a week from 6:30-8am on Monday and Wednesdays. The reduced swim schedule for Orca's is at a reduced rate due since practices are only twice a week for all Orca's.

TREASURER'S REPORT (PRESENTED BY MARK MESDAG)

- Mark plans on revamping the balance sheets to make them more user friendly.
- Aqualaps is nearly at the coach's goal.
 - o ACTION ITEM: Savona, Corry and Scott plan on reaching out to a small handful of swimmers and businesses to verify their desired giving this year.
 - o DECISION ITEMS: Scott shared that he would like to see the updated Aqualaps banners up at the two pools by the November meet. Savona concurred that this should be possible.

GSC BOT Minutes 07/18/18 continued

- The small task force (Sonia, Savona, and Scott) met and discussed what the trigger amount will be in the checking account before we take a portion of the money and roll it into a CD.
 - DECISION ITEMS: Scott shared with the board task force's recommendations (a set amount should be rolled into several CDs on a staggered calendar). The board listened to the task force's recommendations.

- Board oversight areas: the proposed chart was discussed with the board. Amy was offered the meet manager role (with compensation). Amy has not yet decided if she will accept the role.
- Scott discussed the HS swim coach / GSC / HS Athletic Director meeting. The board discussed the
 details regarding GSC's decision to not organize the High School meets during 2018. Equipment
 will be loaned by GSC, but volunteering positions will not be GSC's responsibility. Because there
 is only one home meet this year, Scott and Corry felt that this change should not be too difficult
 for the booster clubs to handle.
