- III. Consent Agenda approved. Joy motioned, Sharon 2nd

- IV. Report of Officers
 - a. President, Bethany – Swim-A-thon donations are coming in. Lots of support. At the banquet, everyone that participated will receive a certificate, list of donors, and all prize winners will be announced.
Received another corporate sponsorship from Frontier Land Services for \$500! We will be adding them to our sponsorship board which is overflowing.
 - b. VP – no report ANC has not had their May meeting, yet.
 - c. Treasurer, Joy – abbreviated report since we just had a meeting April 23rd. Payouts for sr. team fundraising, \$225 scholarship payment, transferred money to the money market, and swim-a-thon and banquet expenses.
