NWT swimming Games coaches selection criteria

CANDIDATE QUALIFICATION FORM This form must be submitted to the Organization by December 15 of the year preceding the games .

Coaches: The Head Coach must be either Level 2: Age Group Coach certified or Level 3: Senior Coach In Training, having completed Swim 301. Assistant coaches must be Level 2 Age Group Coach In Training having completed Swim 201 and the Making Ethical Decisions online evaluation. Both a male and a Female coach shall be selected. If not, enough coaches apply then the Team Manager shall be of opposite sex to the coach. Coaches and managers must fulfil all requirements as put forward by the Games Councils.

Special Olympics Coaches must be Level 1: Fundamentals Coach Trained and have completed the Special Olympics Canada Competition Introduction course, and the Making Ethical Decisions online evaluation. Coaching certification must be completed no later than ninety (90) days before the opening of the Games.

All coaches must be a member of the CSCTA, Swimming Canada and their Provincial Swimming Coaches Association. Special Olympics coaches must also be registered with their Provincial Special Olympics organization.

Coaches applying that meet the above criteria will be selected first. The number of coaches selected will be identified by the Games councils. Coaches may only apply for one exemption if not meeting above criteria. Managers will be selected on a club rotational basis if more than 1 candidate applies. If only one coach is selected the manager must be of opposite gender. Coach /manager development remains a top priority for future games.

This form is to be completed by any person wishing to be nominated for selection as either a coach or manager for NWT swimming at participating Games.

To be eligible for nomination, a person must:

- Be of legal age
- Be a resident of Canada and preferably the NWT
- Have the endorsement of their club or Nominations Committee

Have a sound venerable sector and criminal records check

Meet all relevant criteria as stipulated by the Games committee and Meet Package

Be knowledgeable of the Organizations Policies, Procedures, Morals and Ethics

Be prepared to train/manage the athletes prior to and during the Games. Be aware their services are voluntary and neither Sport North or NWT swimming will reimburse any costs incurred or salaries lost by the individual during the Games or during the training camp .

Collaborate with coaches/manager in a team environment comprising of athletes of either gender.
