USA Swimming Meeting of the Central Zone Dallas, TX September 14-15, 2017

Thursday, September 14, 4:00 p.m.

The meeting was called to order by Coach Director John Bradley. Amy Hoppenrath was present in the role of Non-Coach Director. Parliamentarian/Legislative help Julie Bare, Video Bob Staab, and Central Zone Sport Development Consultant Randy Julian were recognized.

Roll call indicated that LSCs with the exception of SD were present. Sign-in sheets were distributed at roll call and CZ BOD and SAP documents were displayed with Betty requesting that LSCs confirm their members on the respective board/panel.

Officers' Reports:

Zone Director: Amy Hoppenrath reported on the BOD Governance proposal with recommendation to approve. Bill Schalz, Chair of the Task Force, will be available for further discussion.

Secretary/Treasurer: The reports are posted on the Central Zone Convention 2017 page on the CZ website.

Reports of Officers/Committees:

Athlete: Jack Swanson's report is posted. CZ athletes have a presence on social media including Facebook, Twitter, and Instagram and also on the CZ website. The goal is to get one athlete from each CZ LSC on the CZ Athlete Committee. There will be a camp in Houston at Rice and 2 athletes from each LSC will be able to attend.

Officials: Anne Lawley's report is posted. A Task Force will work with the officials as the Futures meets and the Zone meets are the same week and the distribution of officials is a challenge.

Disability: Jim Peterfish submitted a report. Jim thanked CZ for its inclusion of the D2 athletes in the 14 & U meets. There was a bit of a communication issue, but the feedback was positive. The goal is to grow the numbers of participants.

Open Water: Rick Walker was not present. Kevin Milak gave the report (also posted) for Pleasant Prairie – the fifth year for hosting. A video was shown of some of the activities. 272 athletes participated. An OW Officials' Clinic was held. There are plans to use the Zone OW meets as qualifiers for the National and Junior National Open Water Championships in Tempe AZ in the Spring of 2018. Dave Johnson spoke regarding national Open Water happenings and noted that there were 1100 participants at the zone level.

Break: Tim Hinchey, USA Swimming's new Executive Director, greeted the Zone.

Multi-Cultural: Pam Lowenthal submitted a report for the Multi-Cultural Meet held in Columbus, OH. Thanks to Christine Thompson of Ohio State for her contributions to a successful meet. The 2018 Diversity Camp with host four (4) athletes from each CZ LSC (should they choose to send) and it is recommended to select two (2) alternates. Camp will be in OH, location TBA.

Zone Board of Review: Beverly Brister was not present. Report was filed and posted for the BOR activities.

Sanction Appeals Panel: Amy Hoppenrath reported that there were no Sanction Appeals in 2017

 - (1) <u>800 Freestyle (Timed Final):</u> The <u>13-14-800 shall be timed finals with the</u> fastest seeded heat <u>of 13-14 shall swim</u> <u>swimming</u> in finals. <u>In the morning preliminary session, the fastest seeded heat of 11-12 girls shall swim first, followed by the fastest seeded heat of 11-12 boys, followed by all others seeded by time, swum fastest to slowest with age groups and genders combined.</u>
 - (2) <u>400 Freestyle</u>: The 11-12 <u>800 400</u> shall be timed finals with all heats the fastest seeded <u>heat</u> swimming in <u>finals</u> the morning prelim session. The remaining heats shall be swum fastest to slowest in the preliminary session, alternating girls and boys.
 - (3) 400 Individual Medley (Timed Final): The fastest seeded heat for 11-12 and 13-14 shall swim with finals. The remaining heats shall be swum fastest to slowest in the preliminary session, alternating girls and boys.
