

C.S. Region VIII Addendum to Spring 2023 Meet Book

Entry Procedures

USA-S is unable to furnish an entry platform like the OME for this sectional championship.

This addendum outlines the key entry requirements that you will need to follow to submit entries to the March meet. There are additional post entry closing and proof of time procedures outlined in this addendum. All sanctioning requirements originally submitted with the Meet Book are unchanged and remain in effect. The only changes are specific to dealing without a functional OME. Entry and Proof of Time.

Entry Details

The Entry Deadline remains the same as before; Monday March 6, 2023, at 7:00 pm CST. The qualification period remains Sunday March 7, 2021, and ends Monday March 6, 2023. Proof of times should be within these dates.

An entry file compatible with a HyTek entry platform must be submitted to the CSRVIII Entry Chair, prior to the Monday deadline. Email to R8entries@gmail.com. (Greg Huskey 573-228-0385).

Entries for the 50 Fly, 50 Breast and 50 Back require close attention. Meet Manager will not allow an event to be labeled as a 50 but have the qualifying standard as the 100. The 50 Fly, 50 Breast and 50 Back will be labeled as the 100 Fly, 100 Breast and 100 Back under the description of events within the correct order of events. The difference between the 50 of stroke and the 100 of stroke is the event number. Event 109/110 is the 50 Fly. Event 119/120 is the 50 Breast. Event 129/130 is the 50 Back.

Entries for bonus events must be selected and clearly labeled as bonus events.

Any entry file submitted with incorrect entries that are not revised and/or returned prior to the entry deadline, will be entered with the LCM bonus time.

Psych sheets will be electronically sent to the contacts listed on the entry email. Any entry files not submitted prior to the entry deadline will include an additional \$50.00 per swimmer charge up to \$300.00 for a club. Entries received after the deadline will be \$30.00 facility fee

per swimmer, \$20.00 surcharge per coach, individual entry fee of \$26.00 and each relay of \$52.00.

PROOF of TIMES

All entries that are received in the correct format will be accepted as meeting the qualifying entry time for that event. Priority or Bonus times. By submitting these entry times, it is agreed that all entry times are valid and have been achieved according to the entry requirements outlined in the 2023 Spring Meet Book. Times may be proved by a USA S sanctioned meet , USA Sanctioned Approved meet, USA Swimming Observed swims.

Any entry time that is submitted prior to the entry deadline, that does not comply with the entry procedures of the meet will be returned to the applicant for prompt revision. Any entry that is not corrected and returned to the Entry Chair prior to the entry closing will be entered at the Long Course Meter Bonus cut for that specific event.

All times must meet or exceed the listed entry time for each event. Any time swum that does not meet this standard must be proven by proof of time from acceptable meet results comparable with the guidelines of the Meet Book. It is the responsibility of the individual athlete or club representative to provide either a hard copy or electronic confirmation of compliance of the qualifying time within the session the event is swum. Failure to resolve the swim proof of time question in the session will result in a fine of \$35.00 for the first incidence. Failure to prove a second event swim will result in being barred in the next prelim session from further individual and relay competition in the meet. The fine for the second offense will be \$80.00. Any athlete who fails to pay any proof of time and leaves the competition prior to resolution, will be subject to being barred from any future sectional championship and be fined \$400.00.
