Discussion topics:

What is your LSC doing to make swim meets/swimming more accessible?

MW – Sanction fee/splash fees, etc. are cheaper for Intrasquad, Dual, Single session meets are cheaper.

MW - Templates are available

MW – Mid-week single session meets are encouraged. (teams often don't want to put forth the effort – parental involvement is often lacking, pool availability is also a struggle)

IN – Central Zone Multi-cultural meet – opening up to Outreach, Premium, Seasonal, Flex athletes that meet requirements. IMR Award – instead of High Point.

OK – Mid-week short meet is often taken advantage.

AR – Short series of meets is successful. Planned ahead of time when negotiating pool rental for season.

MN – Block Party pilot

What is USA Swimming currently doing well and what growth opportunities exist?

The fact that they've asked for the feedback is good! Starting to realize that they need to take some risks.

Organization needs to find a way to be less dependent on registration dollars.

Example of cost to become an official (membership, background check, clothing requirements) – Clubs or LSCs are the ones that give any help. Would help if USA Swimming would create a different level of membership to help with this.

Educational opportunities – investment has been made. Clubs/LSCs to incentivize coaches/officials to take the trainings that are available.

Leadership and Services that they provide are good. LSC Governance Guidance that they've provided are excellent. Communication is KEY. Miscommunication internally causes problems for the LSCs and membership. Make sure WHO the communication affects are the 1<sup>st</sup> to know.

Use Zone Directors to help get communication out to membership (prior to general membership)

Update outdated information/documentation/procedures. Possible outsourcing opportunity.

Ticket System – Change the message to membership to go to LSC first and then let the LSC escalate if they can't solve.

MW - Commented that #'s are down/splash #'s are down. LCM facilities are VERY limited.
