April 2024	Meet entries & special event registrations open
June 2024	Go Live
September 2024	Meet evaluation feedback

- Day 2: Morning Timed Final session; **Team Event Banquet Lunch w Guest Speakers. Athletes attend first night of Olympic Trials**
- Day 3: Morning Timed final session. Athletes & Families travel on Sunday evening or have the option to attend additional Olympic Trial session.

Team Event at Olympic Trials

- Central Zone Night at Finals; team seating
- Tickets purchased by Central Zone
- Each LSC invoiced by the Central Zone for LSC Tickets
- Cost estimated at \$60-\$85 and above per ticket dependent on seating preference and availability.
