Registration and Monthly Dues

- Due Date: Monthly dues are due on the first of each month.
- Invoice: On their account, members can view their invoice. If there are any issues with the invoice, members should contact the Club Admin Coordinator @ swimcoachtamitx@gmail.com
- Payment: Automatic bill pay is required, as well as a credit card on file under your account.
 Dues must be received by the 10th of each month. A \$50 late fee applies for late payments.
- Non-Proration: Dues are not prorated upon leaving the team.

Account Hold Policy

Eligibility for Account Hold

- Continuous Membership: Members must have been active continuously for at least four months to qualify for a hold.
- Notification: To request a hold on your account, members must notify the Administration Coordinator by email @ swimcoachtamitx@gmail.com at least 30 days before the 1st of the month of the requested hold date.

Hold Duration and Terms

- Duration: Holds can be placed for a maximum of 30 days.
- Request Procedure: Written requests must be submitted at least 30 days prior to the 1st of the month of the requested hold date.
- Approval and Fees: Holds are subject to approval for the hold period.
- Since the team may have a waiting list, it is unfair to hold a spot for a swimmer who is not attending practice. Athletes may be charged \$50 per month to retain their place on the team.

Resuming Activity

• Members must resume dues and participation after the hold period ends.

Registration and Monthly Dues

Withdrawal Policy

- Notification: To cancel membership, members must notify the club Administration Coordinator by email @ swimcoachtamitx@gmail.com 30 days before the 1st of the month of the planned departure date.
- Example: If planning to leave on January 1st, notification must occur by December 1st.

Financial Obligations

- Extra Costs: Entry into competitions or swim meets incurs additional costs. Members can sign up via their account and will be billed to the credit card on file by the deadline.
- Fines: Members are responsible for repaying any fines and athlete surcharges assessed by the meet host or South Texas Swimming.
- Team Registration Fees: Registration fees are non-refundable.

Delinquent Accounts

• Past Due: If any payments are more than 30 days overdue, swimmers will be prohibited from attending practices or entering meets until the balance is paid in full or arrangements have been made.
