Proration policy was reviewed and a motion was made to change to weekly versus semi-monthly. A motion was made to change \$15.00 late fee from each line item to the email notice it is attached to effective January 1, 2012.

Sharon said she is acclimating well to the Volunteer Coordinator position.

NEW BUSINESS:

Carmen brought a concern to the board regarding the current volunteer policy. As a result, the board voted to abolish the \$25.00 penalty fee upon families for not meeting their volunteer commitment effective January 1, 2012. Brett made a motion to keep the 4 session minimum and Ann S seconded the motion. Cara Anderson will try to solicit Chick-fil-A as a new hospitality sponsor. Ann Metzger-Seymour may have a new sponsor as well in the form of a donation. The board approved all proposed bonuses for coaches.
