APPROVAL OF MINUTES:

FINANCIALS/BUDGET:

There are 115 Families and 136 swimmers on team.

Reload able King Soopers cards:

King soopers is starting to go strictly to the reload able gift cards. The benefit to these cards is that people do not have to meet someone at the pool when ever they want to get script. All they have to do is take the card to the customer service desk and request the amount they want put on the card. They are now able to use their credit cards if they like. King soopers will give the team a check every 4 weeks if the team has purchased 5,000 worth of cards. If the team has not purchased 5,000 they will give the team the team a check the following 4 weeks for the 5,000 and any extra the team has purchased. The board has decided to go with this and Lore will order a few cards at the amount of 25.00 to get started until we see how many we will need.
