DRAFT MINUTES OF A MEETING OF THE BOARD OF DIRECTORS OF

NORTH JEFFCO SWIM TEAM

HELD:

This regular meeting of the Board was held on Tuesday, March 11, 2008, at 7:30 p.m. at the Meyers Pool. The agenda for this meeting is **Attachment 1**.

ATTENDANCE:

The directors in attendance were Carmen Babcock, Lori Brown, Dawn Fredette, Mary Geist, Ronnie May, Mitch Menezes, Cindy Pacheco, Brett Stoyell and Stephanie Urbanowicz.

Also present was Evelyn Brown, team Business Manager.

CALL TO ORDER:

As a quorum was present, the meeting was called to order.

APPROVAL OF MINUTES:

The Board approved the minutes from regular meeting of the Board held on November 13, 2007. The Board also approved the minutes from the regular meeting of the Board held on February 6, 2008, with one correction: The annual account review will cover calendar year (CY) 2006, CY 2007 and CY 2008 to date.

FINANCIAL/BUDGET:

The Board reviewed the following financial statements: (i) Combined Budget statements - one for the period from 9/1/07 to 2/29/08 and one for the period from 2/1/08 – 2/29/08; (ii) Profit & Loss statements – one for the period from September 2006 through February 2007 and one for February 2007; (iii) a Balance Sheet as of February 28, 2007; (iv) an Account Balances statement as of 3/2/2008; and (v) a Transaction List – General Account for the period from 2/1/08 to 2/29/08. The Board discussed that the financial statements reflect that

the team is running at approximately \$6,700 better than budgeted. Following discussion, the Board accepted the financial statements as presented.

The Board discussed showing the grocery script cards as an asset on the balance sheet. We currently reflect the expense, but not the fact that the team holds the cards as an asset until sold. As the cards are sold, the balance sheet would need to reflect the decreasing value of that asset.

There are 149 athletes swimming with NJST from 109 families.

Evelyn is continuing to look for the team's 2006 bank records. If they are not found, we will approach the bank about getting copies.

PRESIDENT'S REPORT

- 1. NJP&R Volunteer Recognition the Board anticipates making the presentations at the Pentathlon meet on April 13, 2008.
- 2. NJP&R Clean Up Day the District scheduled this for Saturday, March 29, 2008. The Board discussed asking Noodles and Company to donate lunch for volunteers. Stephanie will send an e-mail to the team.

DIRECTOR ITEMS

- 1. Secretary's Report (Ronnie) Maintenance Agreement for the Copier Ronnie reported that the model year of the copier is 2000. This puts us over the 5 year cut-off for replacement equipment under the maintenance agreement. There were reports that high school teams may have used the copier. This brought up the issue of insuring that we purchase the right level of maintenance contract (i.e., the contract covers a certain number of clicks per year). The Board agreed that user codes should be established for the copier so that only authorized users may make copies. Ronnie and Dawn will get some additional information re the maintenance contract to try to bring it to completion.
- 2. <u>Meet Director's Report (Cindy)</u> The awards for the Pentathlon meet have been ordered. Cindy will get the meet workers' list out.
- 3. <u>Secretary's Report (Mitch)</u> Mitch checked with the City of Arvada regarding obtaining a sales tax license. While the City tax code is clear that NJST need not collect sales tax, it appeared to require registration for a tax license. The tax department at the City confirmed that the City

wants NJST to apply for a tax license. Mitch will work with Ronnie on this.

4. Dawn Fredette's Fundraising Report -

- (i) Swim-a-Thon The coaches have the participation forms to provide to swimmers. Swimmers get a packet once they complete and return the participation form. Dawn Anderson needs a list of donations.
- (ii) Noodles Night Dawn Fredette intends to plan a fundraiser at Noodles & Company before the end of the school year. Ruth Carter will approach Noodles about supporting this.
