- 6. The CSI board retreat leader sent out a board evaluation to help keep the BOD meetings on track and I have attached it for use with our meetings. I think it will help us stay on task on not get caught up in discussing things to death or irrelevant conversation.
- 7. From the questions and information I presented at the new parent meeting last month I put together a new parent packet which includes all paperwork, policies, fees, general information, etc. to be used with new swimmers. I have done this in the past and it may or may not have helped. The most difficult part is making sure there are copies available for the coaches. Ronnie is removing the red ink from it.
- 8. Purchased underwater camera to replace broken one. It will be paid for through the grant given to NJST as a silver medal club earner.
- 9. Purchased and hung new practice fees box to separate meet entries from payments. Beth ok'd this.
- 10. I am going to look into another place to host our website. The guy hosting it now left the CSI board under strenuous circumstances and has done some potentially mean things to CSI as the CSI website host. I have a positive relationship with him and he has not said anything about it and I have spoken to him about other items. The easiest might be to have Go Daddy host since they are the ones we purchased our domains from. I will bring information to the board as I do the research.
