
Coaches Discussion (Brett and Carmen, coaches) Year in Review

- Team Accomplishment
  - Brett Stoyall spoke about the last several months and how well the swimmers have adapted to the new and various ways of training like dryland and open water. He is excited to continue with different philosophies in the pool and the alternative methods of training that are aligned with the time the swimmers have to train at the pool due to COVID restrictions. Carmen Babcock added that the age group swimmers, even the young ones are also doing well and adapting to differences in the pool.
- First TWO Swim Meets Success
  - The first two meets in August and September have been deemed successful with fast swimmings, a great attendance by our team and others registered as well as a generous profit with the August meet of over \$5K and the September meet with around \$8K that will be split between the two hosting teams. It was discussed that we will continue to hold meets in the coming months with slightly different procedures to accommodate for the changing Colorado weather.

#### 2020 / 2021 Outlook

- Individual Coach-led Group Meetings
  - The individual group meetings will be postponed to a later date as the team has very few new families and questions are being addressed on an individual basis when needed.
  - It was offered that any parent can contact their coach or board member to answer any questions they have about the team or the swimmer specifically.
- Upcoming Swim Meets
  - October 17 & 23 HRA DUAL MEET
    - The procedure will be a little bit different with swimmers staged inside between events. Brett shared a diagram of the traffic flow during this "inside" meet.
    - Technical personnel is needed for the October meet in order to stream a better live feed of the meet and the scoreboard.

The training goals have been modified to accommodate our limited swimming time. The coaches are excited to see something new and will be adding leadership components for the 13-14 group. Other goals will be focused around team camaraderie and making sure everyone is having fun!

## Financial Review and Update / Vote on budget (Lana)

- Update (total) of the financial aid we have received at this time
  - At this time, we have received several thousand dollars of private, public and government funding to supplement the team's income in order to continue paying our expenses. Mainly water time and salaries.
- WorkShare Program
  - The team has been accepted into the Colorado Work-Share program, which provides an alternative to laying off our coaches by allowing them to remain on deck, but with fewer hours. While the coaches will be working a reduced schedule, their dedication to our swimmers remains well over 100%! While receiving a reduced salary from the Hurricanes, they will also be eligible to collect unemployment benefits supplementing the lost wages.
- Present Budget for voting
  - The budget for the upcoming year 2020 2021 was shared and briefed in detail of each major line item outlined in our team budget. See the overview below. The motion to vote and approve the budget was granted.

- Vote to elect/approve new members
  - The candidates were presented and there was no opposition for the continuation of Monica Ryan and Amy LeRoux (Treasurer) as well as the induction of new board members Joanne Compton and Beth Slattery. A motion was made to approve the new and continuing members and voted in favor unanimously.

    - If you have a question on whether or not your swimmer is ready to compete, contact your coach and they can walk you through the process to help you as the parent and the swimmer understand what events should be swam and how these will contribute to the overall success of that particular meet and the how the swimmer can build on these experiences.
