 position. Tommy Leidich term expired. Chris Burns term expiring. Two new Board members needed.

 Alternative needs to be more focused on conditioning and strength training that benefits swimmers specifically and is tailored to the sport of swimming. Proposals to be requested before next board meeting so Board can review prospective proposals, make a selection and have organization in place by early 2019-2020 season.
