Board of Directors GENERAL MEETING MINUTES

- ➤ **General meeting called to order at 5:38 PM.** In attendance were: Kim Daly, Kathy Hellard, Jennifer Wherry, Mike Countryman, Carmen Babcock, Lindsay King, Joanne Compton and Dan Sung.
- > Approval of November 2024 meeting minutes. Kim motioned to approve. Jennifer seconded. The motion passed.

> Financial Report

- Set up automatic payment with APEX for our part of the starting blocks
- Billing people for merchandise from the holiday sale
- All USA Swim Memberships are renewed
- We are down income due to the early-season loss of meets but do not need to touch reserves.
 We budgeted conservatively and beat budgeted Pineapple revenue by approximately \$15K.

Coach's Report

- o AAC
 - NJST didn't get enough lanes to put all groups in the water at AAC;, 1 group Monday-Friday are scheduled for Westy
 - Per lane hour at \$13.50 "discounted" from public rate
 - Wheat Ridge has moved their Friday and Saturday practice to AAC. It is less expensive and for better TEAM interaction
 - Working with Hillary on storage for meet equipment and training gear. We have agreed to split a storage container to store meet equipment, but that has not materialized. The majority of the team items have made their way to AAC.
 - Received, approved and paid November and December water bills.

Wheatridge

- Per lane hour is \$18.00.
- Plan to add practices at WR has been put on hold due to higher lane hour fee.

Westy

■ \$15/lane/hour. They may allow us to keep some equipment on site now that construction is finished.

- The schedule includes at least one group at Westy Monday through Friday to ensure no other teams "move" into the area.
- Have practices scheduled when we are out due to HS meets at AAC through May

- As soon as I have direction, I will contact Hannah and Anna about this summer but will need at least one instructor.

- Meeting with Jennifer Long to discuss issues from last summer and plan for how to make it better this summer.
- I got feedback from Maddie, head coach, on her thoughts for the season and what can be done to improve.
- I got the NJST dolphins and laptop back from Jennifer

Anna Austin who did some coaching last year is jumping in to fill gaps during the holidays.

Admin

- Marissa and I will be meeting to program out the 8&Us for the summer. Looking to heavily recruit for this age group in February and March.
- Attended APEX BOD Mtg November 21st and January 2; next one is Wednesday, January 16.
- Innersquad meets continue for our 8&Us and Stars groups.
- The new equipment fee schedule is in the MOU with APEX
- Starting summer program staffing.
- POWER HOUR set for Friday, April 25.
- Looking to meet with APEX about summer practice schedule and possibly adding summer club teams at Lake Arbor, Secrest and Fitzmorris so I can start a summer club league. I need to contact Safe Splash to see if they would like to be part of the league too.
- Added a concessions option for HS teams hosting meets at AAC. NJST would host concessions and split the profit depending on work to be done. Jerry, Dan and I have put together an outline of how this will work. Jeffco Invite will be our first go at this! They have opted to have NJST run concessions and give 75% of profit to NJST.

> President's Report

Vendors at Meet. The board decided not to open to vendor opportunities to anyone outside of
the team. Going forward, we will roll out an internal vendor application on a pilot basis, each
application for which will be addressed on an ad-hoc basis. All agreements will include a term
limit based on NJST's fiscal year, a waiver to protect NJST and 10% of proceeds from sales going
back to the team. No services that compete with NJST will be allowed, including food sales which
also pose team liability.

Coach Bonuses

- Carmen removed herself from the meeting for this conversion.
- Last fiscal year, the board gave \$8K to Carmen to distribute to her coaches as she deemed fit. The board proposed a 25% increase for this fiscal year, bringing the total to \$10K. Strong consideration and weight was given to the added challenges and scheduling needed on the coach's part to get through the summer and fall with no home pool.
- Taking the same into consideration, the board also proposed a 25% increase for Carmen over last fiscal year's bonus.
- Jenn made a motion to approve a 25% increase in both Carmen's bonus and the coach's bonus pool for the current fiscal year. Jennifer motioned to approve. Lindsay seconded. The motion passed.
