Call to Order

Old Business:

Change to college policy. No longer required for summer college swimmers to commit to a full trimester to swim with team.

Discussion regarding Impact Sports Contract, current and future needs and need for possible additional meeting for further discussion.

New Business:

Lana updated Board on the passage of the two Jeffco Schools bond initiatives, 5A & 5B and what the passage or failure could mean to the future new facility and the City of Arvada's next steps. Discussion that in January, Arvada City Council plans to talk to board/team about next steps and how Jeffco Hurricanes swim team could help facilitate the new facility. At time of meeting no determination on passage or failure of bond issues 5A & 5B.

Update on RMT acquisition: Acquisition final and Jeffco Hurricanes present at Wheat Ridge Recreation Center facility. New coach, Sarah Corcoran, hired as Lead Site coach and scheduled to start with team on November 26, 2018. Assistant coach, Peter Hankins, retained and already on deck at Wheat Ridge Site. Open discussion regarding recruitment plan options moving into 2019 and steps team and coaches can take to help increase numbers for Wheat Ridge site, how Arvada site can help welcome Wheat Ridge families to team, suggestion to invite one or two representative members to attend future board meeting, and/or building a Wheat Ridge committee and invite committee to attend future board meeting. Additional discussions required for 2019 as at time of meeting acquisition was very recent.

Financial Report:

- Lana opened up the discussion on need to look into new credit card. Brett to be signer on new credit card application.

Review of Books:

RMT/Jeffco Transition/Recruiting:

Practice Schedule:

High school swimming to begin November and lane use and practice times will be impacted.

- Attended Colorado Swimming Coaches Meeting on October 6
- Attended Colorado Swimming HOD October 7.
- Added Safe Sport information to the website to get in line with USA Swimming requests.
- Created summer club proposals to Candelas Development to be led and coached by Jeffco staff. Troy to serve as point of contact and taking lead on initiative.
- Numerous new swimmer evaluations conducted throughout month of August.
