- Bookkeeping (Lana)
 - Financial and Budget Update Approved!

 - It was requested that the Wheat Ridge water fees be received on a more regular and consistent basis in order to better plan out our monthly expenses.
 - Coach Sarah indicated she would work with Wheat Ridge to obtain an invoice schedule
 - Coach Carmen mentioned that the team may not directly know how much of a pay reduction each coach took with the WorkShare program. It has been requested that the team have a better idea of the percentages and that the unemployment does not supplement the total amount lost while on this program.
 - Through private email, Lana Heare will work with the coaches to understand the program more in depth and understand what percentage of unemployment is being received.
 - Coach Brett included that everyone should also be receiving the current stimulus of \$300 per week.
 - Follow up by Lana and Marie regarding these numbers will be discussed via email following the meeting.
