5. Governance/ open positions update-- GC

6. Financial report/ budget input--Treasurer

Kari- we look healthy. We are 66% towards our income goal.

Expenses- we have only spent 47% of what we planned, but we have significant expenses on the horizon.

Meet revenue- higher than we expected.

Athlete Registration- we are about 300 athletes short, so we are \$8,000 below where we budgeted.

All other LSCs are also experiencing lower USA Swim registrations.

We have money available to use, if we need it. There is money in money markets and bonds, in "safe" interest bearing accounts. Trip Strauss recommended that we look into some CDs.

We have about \$50,000 in reserves

7. HALL of Fame update--Adam

9. Summer heat concerns--Chuck

If the pool temperature gets above 83 degrees, we will have a coaches meeting when the session starts

If outdoor temp is over 100, 10 and unders would swim in the morning.

Steve Hall suggested that a neutral party take the water temperature.

Every 3 years, the HYPR closes for tile work and pool repairs.

Mark Gole suggested we go to Jenks for an indoor option

Evan made a motion to table the heat discussion until the Fall. John Moseley seconds. No opposition.

Mark wants to consider moving 10 and unders to prelims.
