Addendum II

Currently LSC hosts an annual coaches' clinic. Fees are partially paid by club and LSC. A further \$5,000 grant is available annually for coach education. Clubs must apply for specific sum by January 1. Money is to be used for travel expenses, registration, etc. This program is designed to give clubs and their coaches the flexibility to choose the continuing educational opportunity that best serves their needs. The following are examples of possible qualifying programs:

- 1. Coaching conferences, seminars and clinics.
- 2. Business management classes at a local community college or other recognized organization or institution.
- 3. Educational materials (videos, presentation materials, etc) that can be shared on a club wide basis.
- 4. Other educational opportunities and programs that are determined to meet this grant program's goals. Motion passed without additional discussion.
