Swimposium – overview from Lisa Montplaisir

- Approx. 120 athletes pre-registered, plus 10 walk in athletes
- 14 pre-registered officials
- 15 pre-registered parents for each session
 - o 1st session was approx. 20 registered
 - o 2nd session was approx. 40 parents
- 6 pre-registered coaches
 - 15 coaches showed

 - Must be on a Saturday
 - Will not take place during an Olympic year

2019 Central Zone Championship Meet

 - o First time both zone meets will be run in a 10 lane pool
 - Need to sync meets to make sure records are announced at both locations at the same time, etc
- Each LSC has been contacted to determine head Coaches to start conference calls

Zone Policy Change Proposal

Current:

8.2 A.e

Team members with non-conforming times, if allowed by the meet information, will be selected to fill open team positions by the following criteria:

- i. Qualified swimmer (AAA Swimmer) gets to go to the meet. Beyond that, the fastest swimmer from the LSC is given an option to fill the open spots (2 per event), and the list is run through until the spots are filled, based on season best times
- ii. "Time trial" times will not qualify a swimmer for one of the top two spots unless that time is a AAA qualifying time.

Proposed:

8.2 A.e

Team members with non-conforming times, if allowed by the meet information, will be selected to fill open team positions by the following criteria, in the order listed:

- I. Qualified swimmer (AAA Swimmer) is automatically selected for the team, if commitment has been declared.
- Committed AAA swimmers may commit to swimming an event they have a time slower than a AAA time in, with a minimum requirement being an A time.
- III. Remaining spots (up to two positions per event/age group depending on results of above selection steps) will be filled based on the following qualifications:
 - a. Swimmers must have swum a minimum of an A time in their associated age group the first day of competition on the start of the Central Zones competition. A swimmer with a time slower than an A time, will not be eligible to fill a spot on the team.



The next fastest swimmer during the current long course season, including the results of the individual events at the State Long Course Championships, would be eligible to fill the position. Relay leg times from first leg only, will be considered from swims during season but excluding Long Course Championship relays.



IV. "Time trial" times will not qualify a swimmer for one of the top two spots unless that time is a AAA qualifying time. A time trial during the Long Course Championships, resulting in a time lower than a AAA time does not qualify for consideration for zone selection.

Motion made to approve the policy made by Jason and seconded by Kim, to include the changes shown above in RED. Motion passed with no additional discussion.

2019 State SC Meet Review

• Multiple facility changes have been made to address staffing, training, service support, etc during all major events to prevent issues comparable to the 2019 State SC Championship meet.

Headcounts for ND swimming are 1352 swimmers – 60% of the LSC qualifies for state SC – what is a comfortable "percentage"?

- Time standard review may be required
- Possibility of moving to BB for 11-12 girls
- Possibility of changing 50 qualification times for 13+ swimmers since they are calculated, not standard

State Meet Committee – additions will be Lisa Montplaisir and Dan Heckaman

2019 State LC Meet

- We need to look at splitting the sessions, or changing the order of events
- Swim mixed age for 11 and over swim in one session
- 10 and under on their own, with awards like at SC state
- Relays average 1 ½ hours per day

Nominating Committee (General Chair, Treasurer, Technical Chair, Age Group Chair, Safety Chair)

- We need to look to fill the Finance Vice-Chair position being launched by USA Swimming
 - Oversee finances and treasurer position, budgeting, etc

New Business

We LEAD Summit, June 28-30, Norcross, GA

- Build leadership in our athletes cost before 5/2 is \$300 per person, after is \$350 per person, includes summit, transportation to and from, and lodging.
 - Need to identify the swimmers who would want to attend
