- 2019-20 Short Course Meet Calendar and 2020 Long Course Meet Calendar
 - Signup taking place throughout the meeting
 - Short course state March 20-22, 2020
 - Long course state July 25-27, 2020
 - Two weeks prior to Zones
 - Zones August 6-9, 2020
- 2019 State SC Meet Review
 - Air quality conditions have been addressed by the HAC and the WFPS system
 - Response shared with HoD
 - Event staff development
 - Support schedule will be available and on call
- o What is LSC protocol going forward for future occurrences?
 - Request has been made to LSC to develop protocol and communications
- o 1300 swimmers in the LSC, 646 qualified only 4 chose not to attend
- Meet structure was changed to be 10 and under, and 11 and over with the addition of awards for 10 and unders
 - The meet committee will be adding additional members if interested will continue to look at qualification, meet format, etc
 - Athlete committee recommended changes to qualification
 - Currently boys group has exceptions to older 2016 standards
 - Currently girls are B for 12 and under, BB for 13 and over, and 8 and under are manually calculated
 - Request for committee additions Lisa Cramer, Brian Toay, Thomas Jackson, Rachel Carter, Liv Olson, Anna Montplaisir
- 2019 State LC Meet
 - Board has recommended format change review for 2019 LC State Meet
 - Will be reviewed and recommended by the state meet committee
- Zone Policy Change

Team members, if allowed by the meet information, will be selected to fill open team positions by the following criteria, in the order listed:

- Qualified swimmer (AAA Swimmer) is automatically selected for the team, if commitment has been declared.
- Remaining spots (up to two positions per event/age group depending on results of above selection step) will be filled based on the following qualifications:
 - Swimmers must have swum a minimum of an A time in their associated age group the first day of competition on the start of the Central Zones competition. A swimmer with a time slower than an A time, will not be eligible to fill a spot on the team.
 - The next fastest swimmer during the current long course season, including the results of the State Long Course Championships, would be eligible to fill the position.
- "Time trial" times will not qualify a swimmer for one of the top two spots unless that time is a AAA qualifying time. A time trial during the Long Course Championships, resulting in a time lower than a AAA time does not qualify for consideration for zone selection.
