- 3) Review/Approval of Meeting minutes
 - a) Motion to approve minutes made by Bret, with a second by JoDell. Motion passed without discussion or opposition.
- 4) Old Business
 - a) 2019 Midwest All Star Meet Recap
 - Selection was difficult because communication with the coaches was broken down
 - Once team was selected the process ran well
 - Need to develop meet information to communicate and how to reach LSC

 - c) Central Zone Workshop, May 17-19, Chicago, Ill

 - Chris Burnbaum (Athlete) from Aquastorm and Emily Puppe (Coach) from Mandan
 - Will have information on how to have your own leadership conference in your LSC
 - (1) Would be a big benefit to be able to provide information to ND more readily
 - e) 2019 Central Zone Championship Meet
 - Coaching Staff
 - (1) Thomas Wheeling is Coaches' Rep, but has a conflict for coaching will be making a recommendation for head coach to the LSC for approval
 - (2) Looking to expand the coach size if Zones guidelines allows
 - (a) Per guidelines each team is allowed 6 passes recommended one belongs to the manager
 - (i) Shane will work with Thomas to work on wording to provide to Stacy to create a google form
 - (ii) Form will be ready and submitted prior to next meeting so he has a list of applications by end of April
 - Zone Policy Change Proposal

Proposed Policy Change:

Qualified swimmer ('AAA' Swimmer) gets to go to the meet. Beyond that, the fastest swimmer(s) with an 'A' qualifying time in an event at the LC State Championships is given an option to fill the open spots (2 per event), based on the finishing order at the ND Long Course State Championships.

- (1) A time minimum for those events not filled by AAA swimmers if no A time swimmers the position will not be filled
- (2) Time performance is earned during current long course season and/or most recent SC season
- (3) Retain existing policy that states a time trial for a AAA is the only trial that can impact zones selection because it automatically qualifies a swimmer for the event
- (4) Lead off legs of relays only count if they are AAA at state

- (5) Need to address the 50s because a standard does not exist
- (6) Policy to be voted on at 4/27/19 BoD meeting and communicated at 4/28/2019 HoD meeting.
