- Working to make sure we are in continual compliance with safety guidelines

New Business

- 2021 State SC Championship Time Standards
 - Brian Toay 1 year ago the HoD had voted to implement tighter time standards, however, the BoD has voted to not implement the change, but instead continue with existing time standards for the current year
- 2020 18&U Winter Championships
 - o In a normal year, winter Jr. Championship meets are held in two sites on college campuses
 - Due to Covid restrictions, location options were reviewed 18 locations bid for event
 - Events will take place first part of December and results will be combined
 - Time cuts are futures plus 1
 - WFF is slated to host December 4-6, 2020
- 2020-21 Short Course Meets/Schedule
 - In previous years, calendars have been set at the spring HoD meeting this has not happened as a result
 of Covid restrictions
 - Events are being scheduled as locations/cities permit based on local restrictions
 - o As an LSC, we will have very limited opportunities for swimmers to compete
 - Locations that can host are requested to open space as permits to allow other athletes to swim
 - Deck requirements:
 - Minimum deck is similar to a dual HS meet Deck Ref, Starter, Place Judge (order of finish)
 - Page 33 of the USA Swimming Rule Book states(as Janna indicated) that the Ref and Starter can serve(dual rule) as Stroke and Turn Judges, for Dual meets.
 - And so, it appears as long as we have a meet sanctioned as a Dual, then technically, the
 meet can be run with a Starter and Referee, and without any additional Stroke and Turn
 Officials. AND, if we (someone other than me) will support certifying the times Post
 Meet, then from an Officials standpoint, we can run the meet just like our Dual High
 School meets.
- 2021 State SC Championship Meet Bids
 - o Vote done based on electronic messaging through Zoom verified by Dan Heckaman
 - o Teams bidding for host position: Bismarck, West Fargo, Williston, Mandan
 - Each team was allowed approx. 5 minutes to present to the group at large prior to voting
 - Meet dates and locations as voted upon by the NDLSC HoD and BoD collective group are as follows:
 - 10 & under Aquastorm (Second place Williston)
 - 11 & over West Fargo (Second place Aquastorm)
 - If conditions have changed, we may need multiple locations, etc all teams applying will remain in the mix if needed
