A team member is having issues with one of our teams (details being withheld)

Per Bret Haglund



- Email stating athlete was being bullied by an older athlete on the team
- Concerns were brought to the coach
 - Indicated that the issue was not handled so parents brought it to the Board of Directors of the club.
 - Parent stated activity continued and further communication with the BoD was ignored/dismissed
 - o Parent given the option by the BoD to find another team
 - o Parent reached out to USA Swimming and investigation took place

Shane has been in communications with Randy Julian to determine what actions, if any, the NDLSC can take in a situation as indicated above.

Opened discussions to the Board for feedback and/or recommendations.

Our bylaws do not provide us power over how a club chooses to operate their team

Parent was in attendance on the call and provided details indicating solution provided to her was not followed through with by the team.

Shane – suggested providing support and guidance for club operations, and providing options for resolution management of the issue.

Bret – recommended possibly having the team meet with identified LSC BoD members, and local club BoD members to review policy, both operational and bullying, finances, parent communication, etc.
