

- More from Joel. With College swimming being postponed in many conferences and Universities not currently allowing outside events, they are working on updates to camps, clinics, national meets.



• Also from Joel. USA-S has negotiated Zoom Enterprise licenses. If a Club want to purchase for \$120 they must indicate it on their Team Registration and submit to Technical Chair in September. This is an 80% savings and is an upgrade from the licenses currently provided by USA-S. The LSC is responsible for collecting the money as it will be added to the Club Registration process. If you miss September, I believe you then have to wait until next year. I will post the new Club registration form as soon as I receive it.

- *Brendan Hanson spoke on the 12U technical suit rules going in to effect on Sept 1. The new suits will have a green checkmark by the FINA logo. Old suits will need to be individually checked by Referees to determine if legal. This is for sanctioned, approved, or observed meets. Thus, we'll have to check 7th graders at the HS conference and state meets just as we do for tape.

• USA Swimming has increased its options for SafeSport training with the push that all clubs are SafeSport certified no later than December 31, 2020. I am hoping that I misheard this date and that the actual date is 2021. I receive monthly reports of SafeSport certified clubs. We currently have two clubs AQST and WFF who have completed all items and are Safe Sport Recognized Clubs. The first 1500 clubs who become Safe Sport recognized will receive a grant (I believe 500) from USA Swimming. Also, clubs are entered into a monthly drawing to have a zoom visit from a National Team Member.

- All fees have been paid
 - Will reconvene and set application dates for remaining positions
 - o 12 open spots

New Business

- 2020-21 SC Season
 - Sanctioning will be fairly open with small numbers
 - Brian would like to lift to 8 week sanction request restriction
 - Form has been modified to include COVID information required
 - Per Lisa USAS 15 day notice on meet requirements will remain in place
 - Survey will be sent to each team
 - University pools are off-limits in many locations may impact schedules
 - Will need to explore virtual meets in more detail many LSCs have stated this will be their primary route of competition
- 2021 SC State Meet Proposal
 - Proposal to have 10 and under 2/27-28, 11 and over 3/19-21
 - Dan doesn't have issue with no volunteers/officials, that would be part of EDC/WDA
 - Is there issue with cutting season short by a month for revenue?
 - Coaches have issue with event for youngers taking place during EDC/WDA
 - Many coaches are HS coaches also
 - Athletes support split of the meet
 - Not certain about space availability but have issue with the crossover with EDC/WDA
 - All seem to be in agreement on split but issues across the board with timeframe
 - Pat: each club should provide input
- Motion made by Brian Toay to have SC state meet be split into two separate events; 10 and under & 11
 and over for 2021, details of date to be outlined outside of motion, eliminate existing schedule for SC
 meet hosting, and open new bid for each event for 2021.
 - o Motion seconded by Thor Anderson, motion passed.
- State Meet Time Standards
 - Brian stated per policy we have to move forward with time standard changes
 - Lisa noted that USAS Board overrode national time standard changes in light of COVID
 - Abby indicated it would be in the benefit of the athletes to delay change in standards due to current situation – currently multiple items in play impacting swimmers already
 - Bret as a board if we have an agreement to pass standards as in place for 2020, publish on NDLSC site with EMAIL to delegates, it will provide an opportunity to dispute
- Motion made by Bret that Shane/Bret will send notification to membership stating that the time standards for 2021 will remain the same as set for 2020 with advisement from USA swimming as they are refraining standards for national meets as well. Motion second by Pat. Motion carried.

• Minimum Requirements for Officials for Sanctioned Meets



- Current minimum is 5 officials Admin, start, ref, two stroke and turn regardless of deck size
 - Placement for stroke and turn is recommended posted at turn end (allow starter and ref to turn into dual role)
- Waiver of Lack of Officials Fines
- Motion to waive fines for lack of officials for 2020-2021 SC season.
 - Motion second by Brian Toay. Motion carried.

 - Also have votes for Central Zones meetings
- Motion made by Bret as admin vice chair to implement new format for policy manual currently listed on the site under development for 2020-2021 and forward, retiring the existing policy and procedure manual.
 Motion seconded by Lisa, approved with no additional discussion.
- Motion made by Bret to adopt the job description to 1.2 for Finance Vice Chair job description as outlined, to be included in the updated policy manual. Motion seconded by Pat and carries without additional discussion.
- Splash Fees Motion made by Lisa to reduce splash fees during COVID restriction to \$2.75. Second made by Bret. Passed with no additional discussion.

Motion made by Liv Olson to make the following policy changes to 1.2J: Jr Athlete Rep – 15 YOA or Freshman in High School, At Large – at least 16 YOA or sophomore in High School, No two reps from the same club can be athlete reps at the same time unless there is no other interest in the position. Motion second by Abby Triplett. Motion approved with no additional discussion.
