#### State Meet

- Pat has heard from multiple coaches that they are not happy with the split meet for 11-12 and 13+
  - No team mates, relay issues, competition issues, etc...
  - Not one coach in the West in favor of splitting the event
- Per Lisa 350 Max on deck including athletes, coaches, officials, workers, etc / 500 spectator
  - o These numbers are larger than ND Smart Restart because there is a "not to exceed" number
  - General support from the NDLSC members in attendance to make a decision and stand by it, not flex based on pressure from specific groups
- Motion made by Dan Heckaman to run the West Fargo Meet in a combined session, with a second by Janna Schill
  - Parents may pull athletes from the state championships because they can't attend
  - o Approve Kristin, Brian, Stacy, Pat, Janna, Bret, Lisa, Liv, Anne, Dan, Abby
  - Decline Angie, Wallace
  - Motion carries
  - o Line of communication will stay open with the Hulbert as swimmer numbers finalize
  - o Communication will be sent from the NDLSC through the site
    - Janna and Pat both volunteered to proof communication prior to distribution

#### Mask Guidelines

- Williston has posted documentation that shows them not in compliance with NDLSC/USAS mask compliance
  - Per Pat documentation says "Should"
  - o Brian confirmed with Joel Shinnifeld that the rules require compliance, including Fans
  - Bret received notice that Sanctioning stipulations have been extended through April 30<sup>th</sup>
  - Comments were noted on the Facebook page that swimmers were committed based on the meet information, and then that information was not followed
  - o Wallace asked about enforcement responsibility:
    - Meet Ref / Deck Referee / Facility Manager dependent on status of meet
- Per Bret Haglund: It is my understanding that Williston did not follow the sanction guidelines stated by NDLSC
  and USAS within their own meet information, and thusly broke their meet sanction and make a motion for "not
  approving" their next meet sanction request. For NDLSC to keep swimming we need to enforce the sanctions
  that are approved and to move forward in this current health climate.
  - o Second was made by Brian Toay
  - o Discussion if appeal is filed through USA Swimming, will we be in the right?
    - Regardless of USAS rules, they were not in compliance with their meet information
    - Kristin: is the board responsibility is to set the expectation... I don't think we want to be responsible to police everyone – How does it help the athletes to not give them a sanction
    - Bret: According to NDLSC P&P as of today, our policy of not following meet sanctioning is to not allow sanctioning of future meets.
  - Clarification motion is for March 6<sup>th</sup> meet
  - o Approve: Brian, Bret, Liv, Janna, Dan, Angie

- o Decline: Wallace, Pat, Anne, Stacy, Abby, Kristin
  - Lisa: No; with the caveat that they are told by someone other than Brian that this was a lengthy discussion and continued failure to comply will result in loss of sanction



- Supported by Stacy, Pat, Janna, Anne
- o Motion did not pass Bret will reach out to the team to discuss impact and future impact
- Per Janna Schill: I make a motion for the NDLSC to require masks at all USA Swimming related events including practice and meets.
  - Friendly amendment: Until further notice, all athletes, coaches, spectators, officials, and volunteers are required to wear a mask at all USA Swimming related practices and meets within the ND LSC
  - Second by Dan Heckaman

### House Bill

- HB1298
- Communication shared by Lisa Montplaisir from FM Area shared with NDLSC CVB indicated that Counsil reviewed – Brian Toay was part of the review
- Dan Heckaman spoke with Senator Heckaman from District 23
  - She is aware of the bill, but not versed
    - Recommended to the NDLSC / Individuals
      - From a senate perspective, the bill has to start the process of the hearing so communications can flow
      - Contact your district senators
      - A unified approach holds more merit
- Pat spoke with Shannon Rore-Jones NLSA Parent / Representative
- Bret requested we reach out to division chair request was declined by Kristin was sent instead by Bret response has not been received yet
- Stacy spoke directly with Ben Koppelman from Cass County bill sponsor
  - Intention is to protect the fairness of competition for athlete
  - o I pointed out that I am not addressing initial focus but the unintended consequences of the bill
  - As it stands it will end youth sports, in my example specifically USA Swimming
    - He stated that we could just create our own rule and it would take care of the issue didn't understand that we can't override our governing body
    - Impact would apply to all local teams tied back to USOC swimming, hockey, gymnastics, etc...
