- This will be held virtually in a special meeting of the National HoD on June 30, 2021 (3pm, MST).

- o Empowering Olympic, Paralympic, and Amateur Athletes Act
 - Federally requiring 33.33% athlete representation to the USA Swimming HoD
 - USOPC Bylaws:
 - specifies at least 20% must be 10 Year Athletes
 - specifies at least 13.33% must be 10 Year+ Athletes
 - Legislation does not dictate the ratio
 - multiple scenarios being discussed
 - o Ratio composition
 - Weighted voting
 - Urgency for the special meeting on 6/30/2021 is to seat an Athletes Advisory Council (AAC) to elect and seat the athlete representation, as well as establish their definition and vote composition prior to the Annual Meeting in September.
 - The USOPC is poised to find USA-Swimming in violation of NGB requirements and assume control of our NGB if requirements are not met by the deadline of 12/31/2021, without guarantee of recertification.
 - USOPC priorities:
 - 10 Year and 10 Year+ athletes
 - Independents
 - o Possible USOPC consequences of violation:
 - Resignation of current USA-S BoD, and replacement with a board of at least 50% completely independent membership
 - HoD permanent disbanding

- USA Swimming Meet Sanctioning (May 1, 2021- July 31, 2021)
 - Pursuant to Article 4.7 of the USA Swimming Corporate Bylaws, and in the interest of member safety due to the ongoing COVID-19 pandemic, the USA Swimming Board of Directors has taken the following actions related to meet sanctioning, with the advice and consent of the Operational Risk Committee, Rules & Regulation Committee, and legal counsel:
 - Amendment of Articles 202.4 and 202.6 of the USA Swimming Rules to require certain COVID-related precautions in order to issue meet sanctions and approvals, including a safety plan, assumption of risk, and release of liability, which will remain in place through July 31, 2021.
 - As always, USA Swimming, Local Swimming Committees (LSC) and club activities must follow state and local guidelines

Zones proposal for 30 age group swimmers

3 coaches 1 Team Manager
(This could change if we have more athletes attend but no more than 4 coaches)
4 flights x \$500 = \$2,000
3 hotel rooms x 5 nights x \$150 = \$2,250
Rental car 6 days = \$610
Per Diem \$100 per day HC/ \$80 per day AC/ \$30 food/ 6 days = \$2,100
Total = \$6960

Entry \$60 per athlete average from last Zones WF = 30 x \$60 = \$1800 for meet entry \$125 per athlete for gear 30 kids = \$3,750

Total = \$12,510

(MINUS) Entry per athlete \$75 = \$2,250 from athletes to LSC (Hope to have at least 30 athletes commit)

Cost to LSC = \$10,260

Rental Car option for 3 coaches and 1 team manager = Full size rental car \$800/plus gas roughly \$250/\$300 = \$1,100 Mileage roughly \$36 miles each way x .56 per mile. Roughly \$950/\$1000 for mileage

Things to remember:

Even though it looks and feels different than what ND is used to, it's still a LSC competition. Not individual teams converging on one place. There are coach limits based upon number of swimmers. At this time there are no spectators, all will be watching streams from local establishments and such. We have to have a Team ND Head Coach, at least 2 assistant coaches, and 1 Team Manager. The biweekly calls that will be starting soon will require the Manager and ND Head Coach to be on. Susan will get the entry file and need to get the Team Manager file to the Head Coach. I have the NDLSC Computer and will not see Susan until state but with 2 weeks it can happen at state. She should run a AAA times list from SC and get posted to Team ND. The coaching staff should be reaching out to those AAA to get confirmations on attendance or not.

Consensus supports the format of the expense overview.
