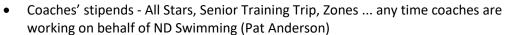

## Membership:

- Propose to stop our Monthly Calls next meeting will be BoD/HoD in October in Fargo/Moorhead
  - Revert to policy schedule which indicates two face to face (fall and spring) offset with virtual in winter and summer
    - Each position is responsible for sending updates to the BoD in between meetings
- Creation of an athlete executive committee (aec) for the NDLSC (Megan Schill)
  - o Recommendation coming from USAS and Zone levels
    - Megan will work to get the reps identified at the team level for not listed on the directory
    - Meeting will be held at LCS in Bismarck outline the committee, etc
    - Work to make sure the PURPOSE is clear for the team







- o Indicated that coaches will not commit because of current pay structure
- Current policy is \$100 per day for head coach, \$80 per day for assistant coach
   / per diem is \$30 per day
- Zones coaching structure for 2021...adjustments to policy for future (Pat Anderson)
  - o Pat will be head coach
  - Cam Elmer asst coach
  - o Annnelisse Bruns asst coach
    - Would like to consider changing format going forward including four coaches look at having coach breakdown as follows:
      - 10 and under
      - 11-12
      - 13-14
      - Administration
    - Current Policy:
      - 8.2.E.(2) The coaches' representative for that given year of Zones will be the head coach
        (or will select an alternate
        with input from the General Chair) for the Zone Swim Meet and will appoint the
        assistant coaches with input
        from the General Chair and alternate head coach if applicable.
      - (3) The ND LSC will provide at least one coach per ten athletes, with a minimum of two coaches for prelim/time, finals/finals meet formats.
    - Dan as requested that Anne and Pat will work together to identify final budget for zones
- Zones minimum standard to attend...discussion for 202... (Pat Anderson)
  - Pat is indicating that policy is restrictive and wants to allow swimmers with less than an A time to be considered for the team.
  - Motion made by Pat Anderson to change policy 8.2 to allow the zone staff to be able to enter 2 swimmers per event for zones as meet information allows, with a second by Wallace.
  - Clarification on how the swimmers are selected based on season or state meet

Motion passed with 7 yes and 5 no.

## - Action Items:

Pat will research and will submit a policy change request specific to pay. Recommendation is to also review all other policy areas that are specific to coaches to make sure they are updated across the board.
