Diversity

The expenses for the 2017 CZ Multi-Cultural Meet were \$8,551; income received was \$7,358, resulting in a loss of \$1,193. The total expense budget for the meet was \$16,000 but only spent slightly more than half of it.

Outreach

To date, we've spend \$12,607.57, \$5,277.57 over budget. The majority of the expense is the equipment (suits, goggles, fins, hand paddles, caps) to enable the 104 participants to practice and participate in meets. Included in the YTD total is travel reimbursement for the athletes to participate in away meets.

Upcoming Expenses

I would like to pick up the meet entry fees for two athletes – Carson Bruner and Hannah Lebamoff - who competed in the 2017 CZ Age Group Championship Meet in Rochester, MN. These athletes were an inspiration to all who witnessed their participation as they were embraced by teammates, opponents, coaches and spectators. They both participated as D2 (para) athletes at the meet. Total expense would be \$412 in total. Breakouts are listed below.

Carson Bruner (12), para athlete, had \$236 in total payments to Ohio Swimming, the breakdown is:

\$36 in entry fees \$5 swimmer meet surcharge \$40 team shirts \$5 Ohio team cap \$50 Ohio coaching fee \$20 team picture (1)



Re: OSI Treasurer's Report

- 1. YTD Financials as of fiscal July (P11)
 - a. Outflows = \$769,169 vs our \$881,834 budget, or 87% spent YTD
 - b. Inflows = \$771,062 vs our \$881,834 budget, or 88% collected YTD
 - c. YTD Net Surplus = \$7,892



- 2. Forecast for remainder of the year On track, **CONTINGENT** on collection of outstanding Membership Fees. If we miss the collections in August, they will come in later, most likely September, so if we do miss budget, it will be a timing issue, not a permanent loss of funding.
 - a. We will see planned and anticipated increases in a) Outflows of \$26K Meet Expenses for just wrapped up LC Meets; b) \$47K Inflows for collection of outstanding Membership Fees; and c) \$30K to \$35K of Outflows for remaining Zone Team expenses (depending on how the food expenses shake out, we may see an overspend for this year's Zone trip, primarily related to the longer journey/expenses of travel to Minnesota).
 - b. We are trending OK vs budget on a line item basis. Overspend has occurred in some budget areas (Convention \$5K, Outreach Gear \$4K, and Swimposium \$9K), but are offset by other underspend in other areas (Diversity \$7K, Sr. Travel Fund \$13K, Officials Travel \$14K).
- 3. Priorities
 - a. Registration Process
 - i. See summary of \$47K net receivable outstanding related to FY17 registrations. Erin is working to collect.
 - ii. Next Registration Process Task Force meeting will be scheduled soon after the budgeting process is finalized. We will discuss best practices from conversations with other LSCs, including best practices of leveraging invoicing capabilities of Quickbooks and electronic payments through Team Unify.
 - b. OSI Internal financial controls we will collaborate with Kirsch to improve internal controls for upcoming FY18

OSI REGISTRATION DATA ANALYSIS FOR FYE 8/31/2017






Membership Services Director Report July 20, 2017 BOD Meeting



2017 Membership Statistics Summary

Post-Olympic final numbers show a 6.2% increase in membership, consistent with the previous post-Olympic bump (6.4%) in 2013. Overall, total membership has reached an all-time high for Ohio Swimming (8590 members). Nonathlete membership was up $^{\sim}4\%$ from last year. Athlete retention remains consistent at $^{\sim}73\%$.





2018 Registration/Membership

September 1 begins the new registration year. The 2018 Fee schedule is posted on the website under Info>Registration and in the Policy Manual (Appendix 1). The website is currently undergoing updates for the 2018 season.

USA Swimming Website

The USA Swimming website was updated earlier this year and OSI link to the USA Swimming website have been updated. Please let the office know if you find any broken links from our website.

Membership/Registration National Committee

I was selected this year to serve on the Membership/Registration National Committee. A couple of items coming:

➤ Member Data Validation Service (MDVS) — This is the new name for the 'Online Registration' that clubs will use to compare their registration files to the USA Swimming SWIMS database. Phase 1 is focused on integration between the SWIMS database and the Team Management Databases. The process will require pre-validation of data (at the club level) before the registration file is uploaded. The files will upload into the SWIMS LSC queue through the Club's Team Management software. This will replace team's sending files to the office for upload to SWIMS. However, the data will still need to be approved by the LSC registrars and released to the database. Projected timing of roll out will be the 2019 Swim Year (Sept 2018). The projected 'soft' roll-out is between Nov 2017-Apr 2018. Now that the new USA Swimming website has launched, resources will be focused toward this project.

ACH Payments

Currently OSI is set up to collect payment via Credit Card (via Stripe vendor) or Checks. Some teams prefer to utilize the ACH payment option. This requires a 3rd part vendor setup (via Plaid) in order to make the process more instantaneous (omitting the micro-deposit option which takes 3-5 days to settle). As soon as time allows, I will set up the links/partnership with Stripe to offer this option.

Update on SB252: Lindsay's Law: Sudden Cardiac Arrest (SCA) in Youth Athletes

- 1. Lindsay's Law applies to all public and private schools and all youth sports organizations for athletes aged 19 years or younger whether or not they pay a fee to participate or are sponsored by a business or nonprofit. This includes:
 - a. All athletic activities including interscholastic athletics, any athletic contest or competition sponsored by or associated with a school.
 - b. All cheerleading, club sports.
- 2. The intent of this is to law is to develop guidelines and other relevant materials to inform and educate students and youth athletes participating in or desiring to participate in an athletic activity, their parents, and their coaches about the nature and warning signs of sudden cardiac arrest.
- 3. This law appears to be for:
 - a. Any school operated by a school district board of education;
 - b. Any chartered or nonchartered nonpublic school that is subject to the rules of an interscholastic conference or an organization that regulates interscholastic conferences or events.
 - c. An athletic contest or competition that is sponsored by or associated with a school that is subject to this section, including cheerleading, club-sponsored sports activities, and sports activities sponsored by school-affiliated organizations.

- 4. Implications for Ohio Swimming, Inc.
 - a. Kris Moellenberg (Senior Coach Rep.) and I met on 7/27/17 to discuss this recent legislation and any potential impact for OSI.
 - b. We offer the following recommendations to the OSI Board of Directors for their consideration:
 - i. We do not think that this law directly applies to organizations such as Ohio Swimming, Inc. but this may be a question for our legal representative (John Mackay) to look into.
 - ii. We would recommend "asking" or "requiring" our coaches to watch the SCA Coaches video (approx. 18 min. in length) annually and review the informational handout.
 - iii. This video simply explains what SCA is and how to be aware of it. Any follow-up and/or emergency procedures are both currently as well as adequately covered under our coaches' current training requirements.
 - iv. Under the law, parents & athletes are also required to watch a similar video (approx. 16 min. in length), review an informational handout, then sign a designated form.
 - v. While we think we should make this information available to our parents as well as athletes, and encourage them to review the video as well as the informational handout, we do not think that we should require them to sign a designated form.
