- ***There must be a certified guard on duty at OSI sponsored meets. Failure to have lifeguard at OSI sponsored meets will result in a club relinquishing subsidy. Question called: all in favor, yes; none opposed
- Section 4.6.1 Marshal requirements update and penalty if not followed
- ***Question of whether marshals are included in a contract with Miami, OH. No, they are not.
- ***Mike Yeager: It is hard to find a balance between safe sport, safety, and facilities.
- ***Anne Lawley: USA Swimming is 4 marshals at Championship meets and no recommendation for invitationals.
- ***Mike Yeager: OSI should make it 4 for all meets.
- ***Pam Birnbrich: Some teams are concerned with this policy.
- ***Chip Carrigan: Marshal number is determined by the LSC (2015 USA Swimming Rulebook)
- ***After further discussion: Dave Back made the recommendation of a minimum of 4 marshals at OSI subsidized meets and a minimum of 2 ^ for all other OSI meets.
- ***Chip added "but recommend 4" at ^.
- ***Went back to David's original motion: All in favor, none opposed, motion carries.
