Ohio Swimming, Inc. March 2020 Board of Directors Meeting General Chair Report June 16, 2020

I want to start by thanking everyone for their work. It looks as though we are starting to come out of the lock down with the re-opening of pools at the end of May. Many of the clubs in Ohio have returned to practice and those that have not, are making plans to get in soon. The practice environment is different but we are moving in a positive direction.

USA Swimming is currently working on guidelines and protocols for hosting swim meets. We will encourage our teams to look at these guidelines and make decisions that will fit into their team needs. The meets will begin as Intrasquad and/or be virtual in nature and will also need to fit into the state guidelines. In a survey that went out to our coaches about running a meet in August that would include everyone in the LSC, the majority of coaches voted against running a meet like this. Therefore, we will be looking farther into the future for that type of meet.

The weekly zoom town hall meetings have been well attended. With teams getting back into the water, I decided to move to a every other week format. The town halls consist of a USA Swimming update from Mark Hesse and/or Randy Julian, followed by an educational component, followed by Ohio Swimming updates. I'd like to thank Mark, Randy, Glenn Mills, Ian Murray, Jeff Raker and Kaily Swibes for their time during these educational segments. I also want to thank those of you from the board who have sat in on those meetings as well.

I would also like to thank Mike Yeager and Kris Moellenberg for their service to Ohio Swimming. Both have decided to resign from their current positions on the board. Mike was our long time Safe Sport coordinator and most recently Admin Vice-Chair. He plans on continuing his service on the pool deck as an official and hopes to return to a position on the board in the future. Kris has been on the pool deck for as long as I can remember as a coach. He was always active in the LSC, regularly attending coach and HOD meetings. He served as coaches chair for the past several years. Kris retired from coaching in March and has been busy in Colorado helping a friend with his business. Dan Cherok will go ahead and assume the coach chair role as he would be moving into that role anyway since Kris was term limited. The coach vice-chair position will be voted on in the upcoming election and is currently vacant. I asked Anissa Kanzari to step into the Admin Vice-chair position until the upcoming election, which is a position she is running for. Thank you, Dan and Anissa for assuming those roles and well wishes to Mike and Kris with their endeavors.

I would also like to thank Erin for her work in the office. In addition to switching over the website, she has been working on learning the ins and outs of running zoom meetings, elections and virtual HOD meetings. She has gone above and beyond helping the LSC during this unprecedented time.

As we continue to return to "normal" swimming, we need to be thinking of what we can do to promote our various programs in this new "normal" world. We have no idea how long we may be in this period of social distancing. We will need to be creative to provide services to our members that would normally be done in large gatherings. Please share ideas with those who are in charge of the area you have ideas for. This will take a lot of creativity and must be a total team effort. I'm very lucky to be surrounded by such talented individuals and I'm confident we will be able to meet the new challenges.

Meet Sanctioning Process and Fees:

- 1. Host club submits the following to apply for a meet sanction:
 - a. OSI Application for Sanction (via online application which can be found on the OSI website under Info>Meets/Sanctions).
 - b. At least 90 days prior to the meet's entry deadline, a meet announcement which contains all requirements must be sent to the Sanctioning Chair for review (the meet naming, pre-meet requirements and meet book checklist can be found on the OSI website under Info>Meets/Sanctions). Sanctions numbers will not be issued until meet books are submitted. All meet announcements must meet USA Swimming and Ohio Swimming guidelines.
 - c. A \$25 Sanction fee (time trials are required to have a separate sanction/fee) if submitted by the deadline.
- 2. Deadlines for sanction applications: Check the website (Info>Meets/Sanctions) for deadlines.
- 3. A meet schedule will be created and reviewed by the Technical Planning Committee (TPC) for review and recommendation to HOD. The primary purpose of Technical Planning is to ensure that the sanction schedule meets the needs of all athletes. Attempts to resolve any issues with the schedule will be done in advance of the HOD meeting.
- 4. The proposed schedule (reviewed by the TPC) will be posted on the website no less than 2 weeks before the upcoming HOD meeting and be presented for adoption at that upcoming HOD meeting.
- 5. Any applications received after the Application deadline will be considered late and subject to a fee of \$50.
- 6. Once the meet schedule has been submitted to TPC for recommendation, no further requests will be added until after the HOD approval of the schedule.
- 7. After the Meet Schedule has been approved by the HOD:
 - a. Any meet date changes are to be requested through the Permanent Office for approval by the Technical Planning Committee.
 - b. Any additions to the schedule must also be requested through the Permanent Office for approval by the Technical Planning Committee and be subject to a \$200 application fee.
- 8. The HOD Approved meet schedule will be posted on the OSI website after approval at the HOD meeting. Meet information will be posted as soon as provided by the meet host.
 - a. Meet hosts are responsible for getting any meet information updates to the Permanent Office.
 - b. Meet hosts must get events files to the Permanent Office no later than 30 days before the meet entry deadline and will be posted to the OSI website as soon as received.
- 9. Sanction numbers will not be assigned until all required information has been received into the Permanent Office.

10. Meet Conflicts

- a. A meet may conflict with other meets. However, no meet can conflict with the following OSI meets:
 - Any OSI Championship Meet (Regionals, JOs and Senior Champs)
 - Any OSI Sponsored Events (i.e. OSI Virtual Distance Meets)
- b. If a request for sanction for a club-sponsored meet is received after the application deadline, and there is already an approved sanction for another club-sponsored meet for the requested meet date, Technical Planning may grant approval only if the requester (1) demonstrates that the requested meet will not be in direct competition with the existing meet or (2) the Meet Host(s) for the existing meet concurs with the request, In addition, all appropriate sanctioning requirements must be met.
- c. Dual and tri meets between USA Swimming clubs will receive automatic sanction if all the above criteria are met, the application request is made no less than seven (7) days before the meet and the proposed meet does not conflict with any OSI scheduled meet for the equivalent age or level of ability. Technical Planning has the right to limit the number of dual/tri meets hosted on a single weekend.

11. Meet Entry Fees: Meet hosts may set their own entry fees for individual and relay events, however, the fees are not to exceed the fees approved by the OSI Board of Directors in the table below:

12. Electronic Meet Entries at OSI Sanctioned Meets

- a. Teams are encouraged to use their Team Management software for entry to Ohio Swimming sanctioned meets. Manual (paper) entries are subject to a \$15/swimmer surcharge at the discretion of the meet host. These fees are due at the time of entry submission.
- b. Unattached Swimmers are encouraged to use Hytek's <u>TM Lite</u> for entry submission. Manual (paper) entries are subject to a \$15/swimmer surcharge at the discretion of the meet hosts. These fees are due at the time of entry submission.
- c. Entries to Ohio Swimming LSC Championship meets are required to be electronic. Meet entries for the OSI Age Group Championship meets are through the USA Swimming Online Meet Entry (OME) System.

13. Swimmer Surcharges

a. There shall be a \$5.00 per swimmer surcharge assessed at <u>every</u> Ohio Swimming Sanctioned meet. This surcharge is waived for registered Outreach Athletes.

14. Sanction Fees

a. The following fees have been approved by the Ohio Board of Directors:

15. Facility Surcharges

a. Teams hosting meets are permitted to add an up to \$12/swimmer facility fee which is to be listed in the meet announcement. If a facility fee is utilized, no other host fees will be permitted to be charged (i.e. spectator/admission fees, heat sheet fees). The facility fee needs to be published in the meet announcement and the event file.

16. Appeals

a. Appeals may be made to the Zone Sanction Appeal Panel within 5 days of denial of sanction in writing via email with the two Central Zone Directors. Process for the zone sanction appeal can be found on the Ohio Swimming website under INFO>MEETS/SANCTIONS.

I am requesting that the BOD consider making the Safe Sport Pentathlon meets OSI sponsored events similar to the OSI Championship Series meets (Regionals and JO's). These meets are typically quite small, and the fees paid to OSI (splash fees especially) mitigate most of the profit a host club would generate.
