Both facilities are 8 lanes, 25 yards with Colorado Timing System with full display, continuous warm-up and warm-down will be available throughout the meet.

Finals will be the top 24 times overall between the 2 prelims sites and will be held at the C.T. Branin Natatorium. There will be a Final/Consolation/Bonus heat for all individual events except the 500 Free. The 500 Free will only have a Consolation and Final Heat. Relays also will only have a Consolation and Final Heat.

All diving will be at Canton.

Diving will be run concurrently with swimming and will run until completion with short breaks between each round for compilation of scores. Divers progressing after each cut will be allowed a brief warm-up. There will be no diving in the swimming finals.

Rules:

This meet will be conducted under National Federation and OHSAA Rules.

Entry Limitations:

Any participants who meet time standards are eligible for the meet. An individual is allowed no more than 2 individual events and 2 relays or 3 relays and 1 individual event. Note: Prelims and finals are still considered the same meet and a swimmer may not exceed the 4 event rule.

IMPORTANT: Divers need to be entered in both Hy-tek and Cleanentries.com by January 10th at 9:00PM

No diver will be entered unless their name has been submitted with the official Hy-tek entry to Sarah Tobin at ccsmeetentries.com. Swimming Entry dates apply. Entries due January 10th, 2026.

Dive sheets will be entered on Cleanentries.com. Click on Meets – find the NE Classic Invite Diving Meet and register yourself and your divers under your team. You will have to create a user name and profile if you don't already have one. Please note your user name and password for future use of Cleanentries.com for other meets requiring this. Dive sheets must be submitted on Cleanentries.com by January 10th at 9:00pm.

Dive sheets can be altered one hour prior to the event start time.

Below is important information regarding diving for the 21st Annual NE Class Invitational, Saturday, January 17, 2026 at C.T. Branin Natatorium. Please make sure your divers and diving coaches are aware of the following:

All divers must be able to perform 11 dives.

Girls Diving will be first. Girls warm-ups will begin at 7:00 am with competition beginning at 9:00 am. Dive sheet changes will be permitted until 8:00 am (one hour prior to the start of competition). Corrections of errors noted by the diving referee shall be permitted until the start of the diving competition. Failure to submit a completed diving sheet by the specified time will result in the diver being disqualified from the event.

Boys Diving will be second. Boys warm-ups will begin at the conclusion of the girls' competition NOT before 12:00 noon. Dive sheet changes will be permitted one hour prior to the start of competition. Corrections of errors noted by the diving referee shall be permitted until the start of the diving competition. Failure to submit a completed diving sheet by the specified time will result in the diver being disqualified from the event.

Requirements: Listed below

DD. REQUIREMENTS: FOR THE 6 OPTIONAL DIVES:

Girls & Boys – Must have at the least a 2.0 DD for each of the 6 Optional Dives.

- All divers must have an 11 dive score. Divers must send in proof of meet results/score with entry.
- 11 dives must consist of

Order of dives (11 Dive Championship Format)

Prelims: 2 Voluntary and 3 Optionals

Semifinals: 2 Voluntary and 1 Optional

Finals: 1 Voluntary and 2 Optionals

The six (6) optional dives shall include at least one (1) dive chosen from each of the five (5) groups. No more than one optional dive from the same group is permitted through the semi-finals.

Dives are executed in written order.

Divers not entered in the meet will not be permitted on the board.

The first 30 Girls will be accepted for the morning event and the first 30 Boys will be accepted for the afternoon event – appropriate practice times will be allotted for each group. Team entries taken on an individual basis after 30 divers.

Estimated afternoon warm-up times for the Boys will be announced the week of the meet.

There will be a coaches' meeting at 8:30 am to determine judges for the diving events.
