# 2026 Ohio Short Course Junior Championship Meet

## Important Facts About the Meet

- **Entry Deadline:** Wednesday, February 25, 2026, at 12:00 PM EST
- **New Qualifier Entry Deadline (no changes):** Wednesday, March 4, 2026, at 12:00 PM EST.
- **Late Entry Deadline (including entry errors and changes to existing entries):** Tuesday, March 10, 2026, at 12:00 PM EST.
- The times qualification period for this event is from January 1, 2024, to applicable entry deadline.
- Time Standards – All entries must be equal to or faster than the time standards listed in this meet notice.
- Time standards for Swimmers with a Disability – must be equal to or faster than the time standards listed in this meet notice.
- Entry times shall be in short course yards (Y) or long course meters (L). No Converted Times will be accepted.
- **Entry Limits:** Swimmers may enter a maximum of 6 (six) Individual Events plus Relays (excluding time trials).
- OME will be used for all entries, including relays, age up athletes, win it-swim it' athletes and swimmers with a disability.
- There is no Admission Charge for Ohio Championship Meets.
- The 11-14 individual events will be contested as Prelim/Final except for events  $\geq$ 400Y and 11-12 200Y Breast, Back and Fly.
- All heats in 11 & over finals will be swum slowest to fastest.
- The 11 & Over Prelim/Finals Sessions will be run using 10 lanes. The 10 & under events will be contested as Timed Finals using 10 lanes.
- **Time Trials will be conducted on Sunday only, after Finals.**
- The Age Group Committee in consultation with the Meet Committee has the discretion to modify session warm-up and start times; determine the use of two pools vs one pool; and determine the use of starting at one end vs two ends or using chase starts. Any changes will be communicated to coaches within 48 hours past the meet entry deadline.
- Depending on subscription to the meet, the Age Group Committee and Meet Director have the discretion to limit the number of spectators attending the meet in order to comply with facility fire code regulations and also to ensure that the athletes have a comfortable and safe environment for competition.
- **Automatic qualifiers: "Win it and Swim it". Regional Championship Individual Event champions automatically qualify to compete in their event at the Junior Championship Meet. See Entering the Meet Section for details.**
- All teams attending this Championship should be prepared to help staff the event throughout the weekend. All teams will be expected to provide volunteers based on team entries. Staffing will be equitable based on team size. If any team wishes to use the event as a fund raising opportunity for their team, please contact the Meet Staff at [juniorchamps@swimohio.com](mailto:juniorchamps@swimohio.com).
- **All Swimmers, Coaches and Officials attending the Junior Championship Event must be verified USA Swimming members in good standing by Tuesday, March 10, 2026, 12:00 PM EST. There is no 'pending' status for membership.**
- **Deck Pass request deadline for Coaches is via OME and must be requested by the posted entry deadline. Coaches will not be able to access the deck at the event without prior verification.**
- **Only authorized coaches, officials, swimmers and meet volunteers are allowed on deck and must have a deck credential to access the deck.**
- **Swimmers and Coaches Responsibility – It shall be the swimmers and coaches' responsibility to acquaint themselves with all of the information contained in this meet information book and any information or changes announced at the Technical Meeting.**

## Officials

All USA Swimming certified officials willing to volunteer should fill out and submit the electronic Application to Officiate found on the Ohio Swimming website Junior Championship Event page.

This meet may be an Officials Qualifying meet for select certifications at the N2 and N3 initial levels and for select N2 and N3 re-certifications. Officials wishing to be evaluated should indicate that in the Application to Officiate form available on the Ohio Swimming website Junior Championship Event page. Note: To be evaluated for certification or re-certification at any level, an official must work at least 4 sessions at the meet, even if the evaluation requirement is for only 2 or 3 sessions in a specific position.

**Special notice to those interested in obtaining National Certification as a Chief Judge, Starter, or Referee:** First priority for assigned positions will be given to those seeking certification as well as a commitment to working all sessions of the meet. This better serves the athletes and provides a consistent training experience. Preference will also be given to those seeking either an N2 or N3 Evaluation. If the evaluation is for "Recertification", then one must work the minimum number of sessions in each position in which he/she is recertifying. For specific requirements, refer to the USA Swimming website, under Officials>National Certification & Evaluation.

Official's uniform will be white over **black** (preferred) or navy for all sessions. Shorts are permitted for Preliminaries. Long pants (men or women) or modest length skirts (women) will be worn for finals. White covered toe athletic or deck shoes for all sessions if wearing navy bottoms, or black covered toe athletic or deck shoes for all sessions if wearing black bottoms.

## Organization Regulations

USA Swimming Rules	<ul style="list-style-type: none"> <li>At a sanctioned competitive event, all USA Swimming athletes must be under the supervision of a USA Swimming member coach. Arrangements for coach supervision must be made in advance of the meet.</li> <li>Any swimmer entered in the meet <u>must</u> be certified by a USA Swimming member-coach as being proficient in performing a racing start or must start each race from within the water without the use of the backstroke ledge. When unaccompanied by a member-coach, it is the responsibility of the swimmer or the swimmer's legal guardian to ensure compliance with this requirement.</li> <li>The use of audio or visual recording devices, including a cell phone, is not permitted in changing areas, rest rooms or locker rooms.</li> <li>Use of cameras, cell phones or any other recording device is not permitted immediately behind the starting blocks at either end of the racing course(s) during race starts, competition and warm-ups. Please refer to the Safe Sport section of Ohio Swimming, Inc. policies and procedures for further information regarding the use of visual recording devices.</li> <li>Deck changes are prohibited.</li> <li>Operation of a drone, or any other flying apparatus, is prohibited over the venue (pools, athlete/coach areas, spectator areas and open ceiling locker rooms) any time athletes, coaches, officials and/or spectators are present.</li> <li>Flash photography is not permitted at the start of any race.</li> <li>All adults associated with this competition, whether spectators, volunteers, coaches, officials or meet staff, acknowledge that they understand the USA Swimming Minor Athlete Abuse Prevention Policy (MAAPP) and will have an active role in keeping swimmers at this meet safe.</li> </ul>

## Organization Regulations

<b>Safe Sport 360</b>	<ul style="list-style-type: none"> <li>The USA Center for Safe Sport program is a comprehensive abuse prevention program dedicated to creating a healthy and positive environment free from abuse for all its members. Components of the program include, but are not limited to, providing education and training, enforcing policies (such as the Minor Athlete Abuse Prevention Policy), rules and best practice guidelines, promoting healthy boundaries and mandatory reporting of violations.</li> <li>The Minor Athlete Abuse Prevention Policy (MAAPP) prohibits Applicable Adults (as defined) from having one-on-one interactions with minor athletes which are not within an observable and interruptible distance from another adult. Applicable Adults are required to abide by this policy in full during this meet. (<a href="http://www.usaswimming.org/maapp">www.usaswimming.org/maapp</a>)</li> <li>Pursuant to USA Swimming Rules and Regulations and federal law, it is every member's responsibility to immediately (i.e., within 24 hours) report any incident of child abuse, including physical or sexual abuse, to law enforcement and the U.S. Center for SafeSport. Reporting must occur when an individual has firsthand knowledge of misconduct or where specific and credible information has been received from a victim or knowledgeable third party. <b>Technical Suit Ban</b>	Per USA Swimming Rule 102.8.1F, 12 & Under athletes may not compete in Technical Suits at this meet. Please refer to the USA Swimming rulebook for definitions of a technical suit.
<b>Ohio State Laws that are applicable to Ohio Swimming sanctioned events</b>	<ul style="list-style-type: none"> <li>Ohio's Return to Play Law (ORC 3313.539 and ORC 3707.511) requires that coaches and referees either (1) complete a free online training once every three (3) years in recognizing the symptoms of concussion or (2) hold a pupil-activity program permit from the Ohio State Board of Education. Free online concussion training is offered through the National Federation of State High School Association and Centers of Disease Control. Training links can be found at <a href="http://www.swimohio.com">www.swimohio.com</a> under Safe Sport&gt;Concussion.</li> <li>There will be the required number of certified lifeguard(s) on duty at all times at this meet per Ohio Administrative Code 3701-31-04-E-4.</li> </ul>
<b>Waiver/Release</b>	<ul style="list-style-type: none"> <li>By entering this meet, you are granting permission for the names of any or all of your team's swimmers to be published on the internet in the form of Psych Sheets, Meet Results, or any other documents associated with the running of this meet.</li> <li>All participants agree to be filmed and photographed by the host club approved photographer(s) and videographers and to allow the right to use names and pictures before, during, or after the meet such as in public psych sheets, heat sheets, and results or featured on the host club or OSI website or social media or in public broadcast of the event via television or webcast. Parents and guardians of minor swimmers who do not wish their swimmers to participate in interviews or have individual pictures featured on any media should inform their team's head coach and the Meet Director prior to the meet.</li> </ul>
<b>Parental Access and Safe Sport Considerations for Athletes</b>	Should a parent need to access a child who is on deck, the child will be brought to the parent at the pool door or in case of emergency, the parent may be escorted to the child.
<b>Deck Access</b>	<ul style="list-style-type: none"> <li>The Meet Director and Meet Referee reserve the right to limit deck access in the event of overcrowding, inappropriate behavior or for any reason concerning the safety of the efficient operation of the meet. USA Swimming Rules of Conduct and Ohio Swimming Code of Conduct will be strictly enforced.</li> <li>Non-Athlete membership does NOT grant access to the pool deck at any time.</li> <li>Only Volunteers, Coaches and Officials signed up to work/attend the current session will be permitted on deck. Coaches and Officials must meet and have current certifications for all the requirements of membership including successfully passing the required background check and APT course to be on the deck at this event.</li> <li>Swimmers will NOT be allowed to access the pool deck at any time, without a coach member present.</li> </ul>
<b>Spectator Info</b>	<ul style="list-style-type: none"> <li>Ohio Swimming will communicate to Team Coaches directly, any updates about spectator attendance. Should conditions warrant that spectators are restricted, Ohio Swimming kindly asks for understanding in that decision, as it is Ohio Swimming's goal to allow all athletes to participate in this Championship Event, as competition between athletes is our utmost priority. If a swimmer is withdrawn from the meet as a result of spectator limits, entry fees will not be refunded, as that swimmer will be considered scratched from the meet.</li> <li>All teams participating in this championship event will be expected to provide volunteers for the event.</li> </ul>

## Organization Regulations

	<ul style="list-style-type: none"> <li>Ohio Swimming has the right to remove spectators from the facility or disqualify a swimmer from competition if facility protocols are not followed by swimmers and/or their families.</li> </ul>
<b>Code of Conduct</b>	<ul style="list-style-type: none"> <li>Each club is responsible for the conduct of its swimmers and parents. Any person who, in the opinion of the Meet Director, Meet Referee, or Meet Marshal, is harmful to others or to other's property will be required to leave the competition.</li> <li>Any individual who exhibits a behavior of a threatening, abusive, or derogatory manner toward an official or any member of meet operations is subject to immediate removal and further expulsion from the meet. Coaches will be notified of the actions of their respective teams.</li> <li>Good sportsmanship is expected at all times. Bullying or taunting, foul language or derogatory behavior will not be tolerated and will be subject to immediate removal. All volunteers, spectators, coaches, officials and meet staff are expected to be respectful of others.</li> <li>The Ohio Swimming Code of Conduct governs this meet. The purpose of the Zero-Tolerance Code of Conduct Policy is to establish consistent expectations across the LSC in the best interest of our Athletes and Sport. Ohio Swimming is committed to creating a safe and fair environment for all of its athlete members. This policy is to be used as a guide to promote a positive environment and good sportsmanship at meets and events conducted in the geographical boundary of Ohio Swimming. ## Entering the Meet

<b>Eligibility</b>	<ul style="list-style-type: none"> <li>All contestants must be <u>verified</u> USA Swimming members and affiliated with Ohio Swimming Inc.</li> <li><b><u>The USA-S membership verification deadline for meet participants, coaches and officials will be Tuesday, March 10, 2026, at 12:00 PM EST.</u></b></li> <li>Any Ohio LSC swimmer, 14 years and under, with a time equal to or faster than the indicated time standards, may enter the Junior Championship meet</li> <li>Any Ohio LSC Swimmer with a Disability, 14 years and under, with a time equal to or faster than the corresponding parallel time standards, may enter the Junior Championship meet.</li> <li>All swimmers must enter under a team affiliation or unattached. Those swimmers on a team, who switched clubs in the last 60 days before the Junior Championships, must swim as unattached, unless cleared by the OSI Permanent Office to affiliate with their team.</li> <li>Age on the first day of the meet will determine the age group in which a swimmer is entered.</li> <li>Entry times must be times from meets that are entered in the USA Swimming SWIMS database. See proof of times section in this meet information book.</li> </ul>
<b>Time Standards</b>	<ul style="list-style-type: none"> <li>All swimmers aged 10 &amp; under must have a time equal to or faster than the National BB Motivational Time.</li> <li>All swimmers aged 11-12 must have a time equal to or faster than the National A Motivational Time.</li> <li>All swimmers aged 13-14 must have a time equal to or faster than the National AA Motivational Time.</li> <li>All relays must have a time equal to or faster than the corresponding Motivational Time for their age group.</li> </ul>
<b>Bonus Swims</b>	<ul style="list-style-type: none"> <li>All qualified swimmers aged 11-14 with a single individual event may be entered in two bonus events.</li> <li>All qualified swimmers aged 11-14 with two individual events may be entered in one bonus event.</li> <li>All qualified swimmers aged 11-14 with three or more individual events are not eligible to enter bonus events.</li> <li>All bonus entries must meet or exceed the National BB Motivational Time for their age group.</li> <li>11-14 Win It Swim It and Age Up swimmers are eligible for bonus events as described above.</li> <li>There are no bonus events allowed for swimmers aged 10 &amp; Under.</li> <li>Relay only swimmers are not eligible for bonus events.</li> </ul>

## Entering the Meet

<b>Automatic Qualifiers – “Win it and Swim it”</b>	<ul style="list-style-type: none"> <li>Qualifiers can only be from the 2026 SC Regional Championship Meets.</li> <li>These are individual event champions from the 2026 SC Regional Championship Meets who did not achieve a 2026 Junior Championship time standard in that event. If the individual event winner chooses not to enter the individual event at the 2026 SC Junior Championship meet, no “alternates” will take their place.</li> <li>Swimmers with a Disability also qualify as an automatic qualifier if they are an individual event winner in the swimmer with a disability category <b>and</b> swimming against other Swimmers with a Disability in their respective event.</li> <li>Regional automatic qualifiers may only enter the same event(s) and age group at the 2026 SC Junior Championship meet.</li> <li>‘Win it and Swim it’ entrants will be seeded with their time from their qualifying regional event in the corresponding event at the 2026 SC Junior Championship.</li> <li>Please see the <b>Entry Procedures for Automatic ‘Win it and Swim it’ Qualifiers</b> section for entry procedures.</li> </ul>
<b>Age Up Swimmers</b>	<ul style="list-style-type: none"> <li>A swimmer whose birthday occurs between the start of the Regional Meet attended/assigned to their team and the start of the Junior Championship Meet may enter the equivalent events at the Junior Championship meet for which they had the cut times in the younger age group.</li> <li>Entrants will be seeded with their qualifying time in the corresponding event..</li> <li>Please see the <b>Entry Procedures for Age Up Swimmers</b> for entry procedures.</li> </ul>
<b>Entry Rules - General</b>	<ul style="list-style-type: none"> <li>By the act of entering this meet, each team and /or swimmer agrees to abide by USA Swimming Rules and Regulations.</li> <li>Qualifying period: Only Short Course Yard (SCY) times or Long Course Meter (LCM) times achieved from January 1, 2024, until the applicable entry deadline will be accepted.</li> <li>Entries will be seeded as follows: Short Course Yards (SCY), Long Course Meters (LCM).</li> <li><u>There will be No Deck Entries at the Championship Meet.</u></li> <li>Once the psych sheets have been posted, there are no times updates or entry fee refunds for scratches. Times updates can be done via the late entry/changes to existing entries OME record.</li> </ul>
<b>Qualifying Period</b>	<ul style="list-style-type: none"> <li>The time qualification period for this event is from January 1, 2024, to entry deadline.</li> </ul>
<b>Entry Procedures- General</b>	<ul style="list-style-type: none"> <li><b>Entry deadline is Wednesday, February 25, 2026, 12:00 PM EST, no exceptions.</b></li> <li>USA Swimming’s Online Meet Entry (OME) system will be used for all entries, including relays (<a href="http://hub.usaswimming.org/landing">hub.usaswimming.org/landing</a>) under the meet name of “2026 OH SC Junior Championship Meet”. An electronic event file will be available on the Junior Championship Meet page <i>for team planning purposes only</i>.</li> <li>If you check out of OME <u>prior to the entry deadline</u>, you are still able to do the following up to the entry deadline: (1) times may still be updated for those athletes you originally checked out, but the athletes cannot be removed from your roster; and (2) you can still add new athletes/events to your roster and check out again. Once the deadline passes no more edits can be done to your entries.</li> <li>Teams are responsible for reviewing their entries and must notify the entry chair prior to the entry deadline if there are any errors.
