Financials (Jenn)

- Provided update on Feb/March financials (reports are uploaded to OKS.org under Finance Committee)
- Updated on State 14U - all expenses in and will be cutting checks soon to the clubs
- Proposed closing accounts (and existing credit card) at Citizen's Bank of Edmond; have other options (hotel and/or public library) to compensate for lost meeting space
 - Will work with Pam to open new CC via Arvest bank (before closing; then work with Michelle Brown and Pam to close accounts

- State Meet: Still working to identify meet director from one of the West side/Edmond-based clubs
- Vendor Agreement: Will schedule follow-up meeting to discuss either a full LSC agreement or stick to a zones-specific agreement for sponsorship; Jennifer, Bob, Chad, Sam and Scott, along with 2 athlete reps (Kate and Tyler) to discuss and present option at next board meeting
- Side discussion: athlete cutover based on their elections; by-laws state that the new members are effective immediately and current sr reps move to at-large (no vote) through the end of the summer season
- Board meeting schedule proposal
 - Propose 6 mtgs/year (2 in person "april/october"; 4 virtual)
 - Motion Made: Accept Bob's proposal for 22-23 which is Sept/Oct/Jan/April* (retreat)/June/August
 - 1st: Beth
 - 2nd: Carole
 - Motion discussion with feedback including:
 - CE: need more face-to-face, even if meetings are shorter to foster better processes going forward
 - SE: meetings less successful when virtual; need people in the room for relationship building
 - BH: As new member; meetings are more than just business; but building the relationships so work better; but would like more west side options
 - LG: so far current schedule has been working as-is
 - SS: concerns about busy months of Feb/July
 - BH: maybe in future; but now just keep virtual options for those that need it
 - SE: need to have consistency / keep to a schedule
 - DM: try to keep Feb/March to urgent meetings (so less time commitment when all are busy with season)
 - Vote taken; motion FAILED (will remain with current schedule)

 - DM: Unable to attend but will try to connect to virtual meetings when possible
 - Submit expenses using new OKS Expense Form for reimbursement (Bob/Jennifer will be handling hotel rooms and group dinners)
