- B. Finance Vice-Chair \*flipped B and C due to MB late arrival
  - a. Financials as of 7/31
    - i. Net Revenue of \$9,118.54
    - ii. Budget of -25,150.00
    - iii. Still have outstanding/uncleared transactions
    - iv. Issuing reimbursements for Futures, Zones and other meets
  - b. Budget 2022
    - i. Drafting email to coaches (travel/education/zones), officials, athletes and safe sport requesting 2022 budget requirements
    - ii. Will include 2021 budget & current expenditures
    - iii. Need to review # of athletes requesting funding, ensure adequate for next year
    - iv. Action: MB needs budget numbers back to her by Friday 9/24/2021
  - c. Safe Sport Reimbursement
    - i. OKS received \$1500 as 25% of clubs received their Safe Sport certifications
    - ii. At time of the check, the clubs were P66, AESC and Bixby
    - iii. Since then ST (4<sup>th</sup>), Raiders (5<sup>th</sup>) and Lifetime (6<sup>th</sup>) have received certification
    - iv. Determine if/how should OKS split this
    - v. Action: CL asking USAS if still doing the \$500/team; waiting on response from SafeSport/USAS
    - vi. Discussed incentivizing clubs to complete SafeSport; different options including using these funds (not sure if year over year) or using SafeSport budget lines
  - vii. Action: SafeSport Chair and Coaches Rep get together to draft and recommend a policy to the board to approve; Policy could include:
    - 1. Incentives to receive clubs for completing Safe Sport recognition
    - 2. Incentives for other achievements (club recognition/club excellence)
    - 3. Budget can be amended with Board approval even after HOD once policy proposed and approved

#### C. General Chair

- a. Discussion of Governance committee
  - i. Committee usually reviews slate of candidates; we have a set of 3 nominated
  - ii. Discussion of current membership
    - 1. GG confirmed that Max M had resigned
    - 2. Follow-up with Tricia Hoyt to confirm membership
    - 3. GG suggested Mista Burgess as new member to replace PT
    - 4. LG suggested Charles Nemecek
    - 5. Action: BS will provide LG with additional information regarding requirements; to follow-up with Charles Nemecek for possible appointment
    - 6. Action: SE will schedule meeting as soon as possible
    - 7. Action: JS will update membership listing on website
    - 8. Action: DM will reach out to Mista Burgess

- b. LSC was requested to support the special legislation that is changing the makeup of the House of Delegates (national). The restructured makeup will include:
  - i. 40% athletes
  - ii. 40% coaches
  - iii. 20% volunteers/officials
  - iv. Proposed legislation is a replacement for the previous version that was not passed and meets the

requirements as set forth by Congress. Generally board members support, as not perfect, but good changes.

- v. Motion: Send statement to USAS that OKSi supports the pending draft legistration regarding the makeup of the LSC.
  - 1. First: CE
  - 2. Second: LG
  - 3. Vote: All ayes, no nays; MOTION PASSED
- c. OKS logo
  - i. Met with USAS and the LSC is in the queue, most likely not by end of 2021
  - ii. Will need at least 2 athlete representatives to review; Sr. Reps will provide this review
- d. OKS Hall of Fame
  - i. Reviewed document provided by BS (attached)
  - ii. DM: Define the structure of the committees within the P&P; either appointed by the GC or with unanimous consent of the board
  - iii. SE: This should not be a separate entity; though our rules can give it the power it needs to execute
- iv. Will need to include 1 or more athletes to ensure 20% athlete representation
- v. Will setup a basic introductory meeting over the next few weeks
- vi. Motion: The BOD directs the General Manager to lead the working groups to explore the creation of an OKS Hall of Fame. This will be to develop the structure and report back to the Board.

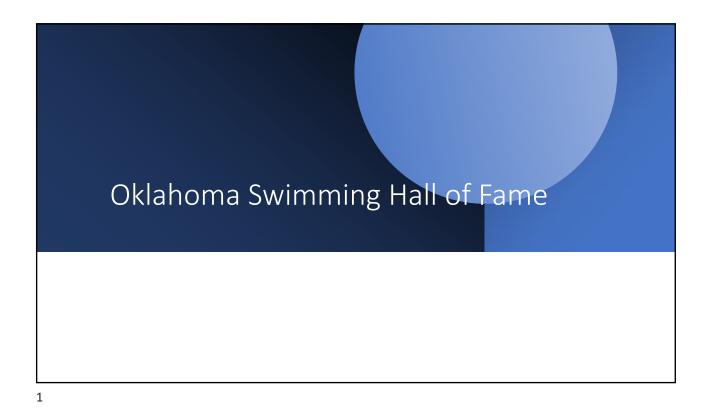
# OKS Board of Directors Meeting September 20, 2021 General Manager Report

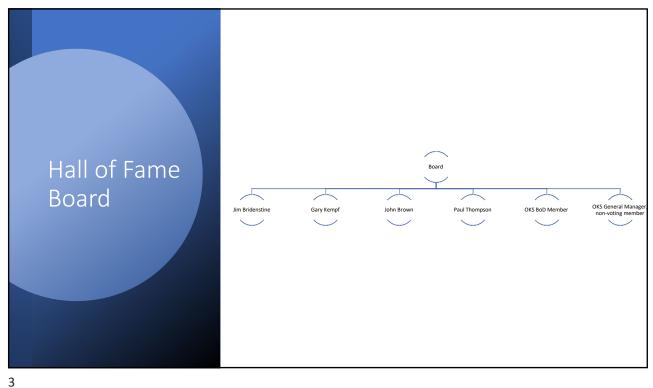


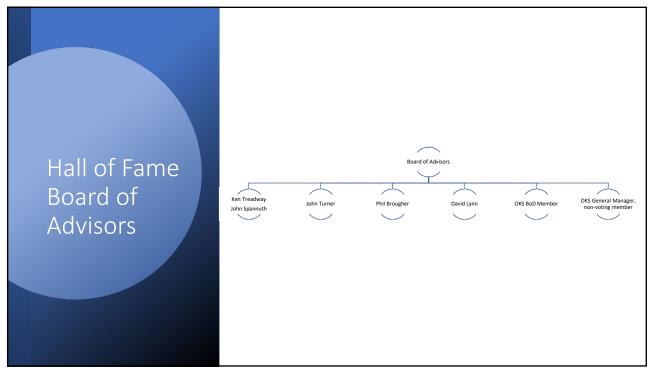
