MB reviewed existing financials

Online Payments Discussion

- MB introduced discussion of allowing online payments for registrations
- BS discussed TeamUnify updates which allow functionality
- Fees involved who's responsible?
 - OKS.org: 30¢ per transaction plus 2.95% convenience fee
 - o Proposal is to increase registration fee to \$3/swimmer; by \$1 per year increments
- SE fees are inline with fees paid by commercial firms; but some legally cannot pass on to teams
- BS Options for fees: Not required to pay online but if so, club responsible for additional fees; while OKS budgets for baseline costs and per transaction fee
- LG concern on additional costs for smaller clubs; would continue to pay by check; will opt for cheapest option
- MB no current ETF (electronic check); closes OKS has is a square account

- BS/MB this would not be a requirement for clubs; but simply an added convenience option
- BS also discussed website update (look and feel) as part of this; OKS would fund upgraded TeamUnify costs which then includes the ability to offer CC/EFT payments
- AB thought at one time clubs were charged \$100 if attended if attended HOD and paid there, otherwise charged \$300 (on top of USA Swimming registration costs)
- CE propose moving LSC charge to \$16 (currently \$15) for 21-22; then revert back to \$15 for 23; and charge convenience fee to clubs that choose to use option
- BS \$95 charge to upgrade website, then \$4 to \$5 per month for using CC which OKS would pay
- MB OKS has \$700 in software budget
- MB will follow-up on using ACH and costs related to that (in addition to CC)
- AB Thinks we pay for a second site for the zones team, can that be consolidated and fees saved?
- MB We do not pay for zones site; AB will dig into it further along with BS; CE/SE on board to consolidate site, see no reason for separate
- Final Proposal
 - o Add \$1 to LSC fee for 2022
 - o Remove additional \$1 for 2023
 - o Teams using CC will pay the 2.95 Convenience Fee
 - OKS will pay monthly fee and per transaction fee
 - CE Motion to approve
 - o AB Seconded Motion
 - MB called for vote:
