28 .1 ATHLETE REPRESENTATIVES -

- 29 Two (2) Athlete Representatives shall be elected, one each year for a two-year term, or until their
- 30 respective successors are elected. At the time of election, the Athlete Representative must (a) be an
- 31 athlete member in good standing; (b) be at least a sophomore in high school or at least 16 years of age,
- 32 (c) be currently competing, or have competed within the three (3) immediately preceding years, in the
- program of swimming conducted by OKSI or another LSC; and (d) have his or her place of permanent
- 34 residence in the Territory and expect to reside therein throughout at least the first half of the term
- 35 (other than periods of enrollment in an institution of higher education). The balloting shall take place via
- 36 electronic vote and/or at a meeting called for that purpose by the Senior Athlete Representative, or
- failing that, at a time and in a manner designated by the Board of Directors. At least twenty (20) days'
- 38 written notice of the election shall be given to all clubs. The Athlete Representatives elected shall be
- 39 determined by a majority of the athlete members of each Group Members, with each Group Member
- 40 permitted one vote for each position to be elected, and in accordance with the OKSI Policies and
- 41 Procedures.

42 .2 COACH REPRESENTATIVE

- 43 One (1) Coach Representative shall be elected, in even years for a two-year term, or until a successor is
- 44 elected. The election of the Coach Representatives shall be conducted via electronic vote and/or at a
- 45 meeting called for that purpose by the Coach Representative, the Coaches Committee or the Board of
- 46 Directors, and determined by a majority of the Coach Members in good standing present and voting or,
- 47 failing that, at a time and place and in a manner designated by the Board of Directors. At least twenty
- 48 (20) days' written notice of the election shall be given to all clubs.
- 49 .3 COMMITTEE CHAIRS/COORDINATORS/AT-LARGE BOARD MEMBERS
- 50 A. The following committee chairs /coordinators/ at-large Board members shall be elected as follows:
- 51 (1) Two (2) Elected Athlete At-Large Board members shall be elected, one each year for a two (2) year
- 52 term. The election shall be held at the same time and in the same manner as the athlete
- 53 representatives.
- 54 B. The following committee chairs/coordinators/ at-large Board members shall be appointed by the
- 55 General Chair with advice and consent of the Board of Directors:
- 56 (1) Safe Sport Coordinator
- 57 (1) Diversity, Equity, & Inclusion Chair
- 58 (2) Appointed Athlete At-Large Board Members [as needed]
