    - R-15 talking about quality control, which was that every host club had to validate everyone how is on deck. This has been withdrawn for now until they work through a better process.
    - R-16 for those of you hosting meets, this will require of all future sanctioned meets. Will
      require a description of your medical supervision that you will have onsite at meets, as well
      as a change to the Map Boarding. This has passed.
    - R-17 120-day rule was changed to 30-days, after long conversations it was changed to a 60-day rule. This you had athletes that fell in the old 120-day rule and the new 60-day rule. Those are being corrected by USA Swimming now. If you still have problems with those unattached swimmers, let Bob and Carole know so they can help you through it.
  - Zone Meets changes moving from a 4 day meet to a 3 ½ day meet. Will now allow some bonus events for athletes who have AAA times, but all that is laid out in the report.
  - Voting this year you didn't have to show that you were a USA Swimming member to participate in the meeting, Next year you will have to. Effective January 1<sup>st</sup>, USA Swimming has passed that in the Rules & Regulations. So, anyone at the House of Delegates will have to be a USA Swimming member to participate in the voting.
