- 1. Code of Conduct for Oklahoma Swimming Athletes Governing Participation in the LSC Programs
- 2. PURPOSE: The purpose of this code is to promote individual, team and program responsibility for the development of first class citizens.
- 3. GENERAL CODE OF CONDUCT RULES
 - 3.1. All participants will abide by this code of conduct.
 - 3.2. All participants will wear designated team apparel during all competitions.
 - 3.3. All participants at USA Swimming sponsored events shall adhere to any curfews set by the Head Coach.
 - 3.4. Male and Female athletes may not be in each other's room on any team trip unless supervised by a designated LSC official.
 - 3.5. Use of alcoholic beverages is not allowed.
 - 3.6. The Use of drugs other than those specifically prescribed by a personal physician is not allowed.
 - 3.7. Use of any tobacco products is not allowed.
 - 3.8. Disrespectful, indiscreet or destructive behavior will not be tolerated. It is the responsibility of each athlete to make every effort to avoid guilt by association with such activities.
 - 3.9. All participants and their parents have a responsibility to do their best to ensure that this Code of Conduct is adhered to and help ensure the safety of these program participants.
- 4. VIOLATION OF THE CODE OF CONDUCT RULES At the discretion of the Head Coach any one or all of the following penalties will be applied:
 - 4.1. Swimmer may be scratched from the meet.
 - 4.2. Swimmer may be sent home immediately from practice or meet at his/her own expense. If there is any extra expense incurred in this return it will be the swimmer's responsibility.

- 4.3. Swimmer may be suspended from the team until the swimmer and parents and /or legal guardian have had a conference with the Head Coach and appropriate disciplinary actions have been implemented. This is automatic with violations of General Conduct Rules 3.4, 3.5, 3.6 and (or) 3.7.
- 4.4. Violation of general code of conduct Rules 3.3, 3.4, 3.5, 3.6, 3.7, and(or) 3.8 on team trips will result in the swimmer being suspended from ALL LSC trips for a period of one calendar year from the time of the infraction.

I/We hereby agree to abide by the Code of Conduct Rules and Travel Policy as set forth above and acknowledge that, should I violate any provision, I will be subject to disciplinary action, as set forth in Part II, including suspension.
