Call to Order: 12:45 pm
1) Roll Call (Sign In)

- 2) Adoption of previous meeting minutes from 23 May 2018 Approved Motion by Sally Stevens, 2nd Dave McCrary
- 3) Report of Officers and Committees
  - a. Athlete Representative Report:
    - i. Need new additions to committee, especially boys.
    - ii. Participation offers opportunity to attend national convention and other events.
    - iii. Must be juniors or seniors.
  - b. **Treasurer:** Bill Hillmer (not present)
    - i. Bob Rettle reports that state taxes are up to date.
    - ii. Andy Allman reports that federal taxes are still being worked; not sure of the deadline.
  - c. **Tech Planning:** Dave McCrary
    - i. Deadline for meet bids is Wednesday, May 1st.
    - ii. Needs Committee members for tech planning.
  - d. Senior Chair: Jon David Williford
    - i. Senior champs went well.
    - ii. Region VIII will be giving refund checks for swimmers that went to sectionals/nationals over the summer.
    - iii. Jon David and athlete representative, Emily O'Connell, will attend the USA Leadership Summit at the Olympic Training Center in April.
  - e. Age Group Chair: Mark Imig
    - i. The trophies for the Bill Karasick and Penny Taylor Awards need to be updated and the names cleaned up.
    - ii. Recommended that the awards be given to both a male and female swimmer of the meet.

- 1) Will need to purchase a second trophy for each.
- 2) Derek Shipp motioned to give Mark Imig \$500 to purchase the trophies and update the existing trophies; 2nd by Bill Woelbeling; motion passed.

#### iii. Division I meet recommendations

- 1) Warmups need to be more equitable in terms of assigned pools and session times.
- 2) Possibly switch the pools in which the 11-12 age group boys and girls swim so that timelines end about the same time (rather than have all girls events in one pool and boys in the other).
- 3) Discussion about problems with MeetMobile getting results for both boys and girls up in a timely manner.
  - a. Reminder that MM is not official results.
  - b. Possibly name the two pools different meet names on MM.
  - c. It is believed that the problems are with the internet connectivity, so the use of a hotspot was recommended.
  - d. Nathan Stooke may be able to help solve the problem.
- 4) Friday night run all events fastest to slowest was recommended.
- 5) Sean Harrison asked the committee to consider a different qualifying standard, possibly between a BB and A standard.
  - a. Q times can be calculated using the results from the current meet.
  - b. An athlete rep spoke to the purpose of the meet allowing more swimmers the opportunity to attend a championship meet. Raising the standard to faster than a BB would limit the number of swimmers who would qualify.

## f. Coaches' Representative: Jason Weisse

- Recommending that teams should only be represented by one coach vote for Coach of the Year to prevent teams with many coaches from skewing the vote.
  - 1) Jason and MJ Woehler will get together and come up with a proposal.

- h. Open Water Chair: Thomas Huggins
  - Reminder Zones Open Water is the chance to qualify for National Open Water
    - 1) 16 & Unders finishing in the top 6 don't have to make the qualifying time to attend Nationals.
  - ii. Swimmers going to National Open Water are supported financially.
- i. Officials' Chair Steve Grimm (not present)
  - i. Andy Allman reported we need more recruiting for officials, especially for parents with swimmers in younger age groups.
  - ii. Looking for ways to streamline the certification process.
    - 1) Ozark pay for official training.
    - 2) Apprentice membership allows them to go through training without becoming full members first
    - 3) webinar/self study
    - 4) hope to have a proposal by the May HOD meeting
  - iii. Ozark does give financial support to officials who work national level meets.
- j. Safety Coordinator/Safe Sport: Diana Rosen
  - i. Christian Rhoten has stepped down as committee chair so Diana Rosen has taken over as chair.
  - ii. Looking into ways to give athletes a stronger voice.
    - 1) what's acceptable, who they can talk to, what options they have
    - 2) USA Swimming has training available to swimmers and parents.
    - 3) Committee is coming up with ways to get the word out.

- m. SWIMS: Angie Dorsey (not present)

- n. Records: Mark Imig
  - i. Coaches need to email him updated records.

### 4) New Business

- a. Swimposium: Andy Allman
  - i. Darcy can no longer be the coordinator, therefore a new one is needed.
  - ii. Looking for recommendations for a headline speaker.
    - 1) If we do the Swimposium during the National Convention week we may be able to get a well known speaker. Convention is in St Louis this year.
- b. USA Flex Membership: Gussie Crawford
  - i. Requires a vote of the LSC.
  - ii. Cost is \$20, plus LSC fee.
  - iii. May swim in two meets but not a championship meet.
  - iv. Covers the swimmer with insurance from USA Swimming.
  - v. Discussion:
    - 1) Can create a large meet when you include learn-to-swim athletes and the DQs can get out of control; swimmers should not be entered in strokes they can't swim legally.
    - 2) We could lose out on traditional year-round memberships.
    - 3) Gussie is concerned with the logistics of tracking who has swum in meets and who is registered with what membership type.
    - 4) USA Swimming is coming up with a system to track Flex membership meet participation but it is not in place currently.
  - vi. Motion was made by Andy Allman to not accept Flex memberships until USA Swimming has a system in place to track meet participation; 2nd by Erik Strom
    - 1) Discussion
      - a. Derek Shipp USA Swimming is trying to offer low cost option for swimmers while being insured; coaches would be responsible for tracking swim meets
      - b. Sean Harrison contact USA Swimming to find out for sure about tracking system
    - 2) Motion withdrawn.
  - vii. New Motion made by Tom Lombardo that Ozark allow Flex memberships but those athletes may not participate in Ozark meets until USA Swimming has a tracking system in place; 2nd by Bill Woelbeling
    - 1) Motion approved with 22 votes.

# d. USA Swimming mandated changes to Ozark bylaws: Andy Allman

- i. Changes will offer more flexibility to the composition of the Board of Directors.
- ii. Establishing a Governance Committee to make sure the Board runs smoothly, to help with transitions, to offer education, etc.
- iii. We have until the end of the year to update the bylaws.
- iv. Andy is recommending that we lower the number of board members which will affect our May elections.
- v. Committee was formed to bring a proposal to the May meeting.
  - 1) Members: Gretchen Allman, Jon David Williford, Erik Strom, Derek Shipp, Bayley Helfrich, Bill Woelbeling, Andy Allman (chair)
- vi. Question was asked as to who is approved to attend the National Convention.
  - 1) Approved positions are stated in the bylaws.
  - 2) If people holding those positions can't go then they are replaced with others.
  - 3) We need to decide by the May meeting who will attend.

## e. Selection of Nominating Committee

- i. Members: Andy Allman, Mark Imig, Jeff McCloskey, Emily O'Connell, Karli Sewell, Derek Shipp, Erik Strom, Jon David Williford
- f. Ozark sponsored Championship meet packets: Thomas Huggins
  - Everyone gets frustrated with Championship meet packets getting posted late.
    - 1) Age group committee formats the meet, not the meet host.
    - 2) Recommending that the age group committee should do the bulk of the meet packet and the host team should just fill in the information pertinent to the location.
    - 3) Currently the process requires a lot of back and forth between the age group committee and the meet hosts.

- 4) The age group committee chair, Mark Imig, agreed that they could do this.
- 5) Next HOD meeting will be May 21 at the Parkway ISC at 7:00pm.
- 6) The meeting adjourned at approximately 2:45 pm.
