There were a total of 4 Registration/Membership meetings. Club portals are going to be used more in the future.

Ozark has 1692 registrations. 1545 athletes and 147 non-athletes.

9 clubs need to sign 2 forms: racing starts and pre-employment screenings.

Gussie requested that registrations need to be done on time so that swimmers will be able to compete.

A request from Dana was made to ask that clubs send registrations for meets together for entire team instead of getting individual checks for each swimmer from some clubs.

We will be going to electronic registrations which may present a challenge for some clubs. Paper registration is time consuming and labor intensive.

Work will be done throughout the year to get all teams using the proposed policy. Missouri Valley is willing to demonstrate their registration process with Ozark in a session to be held in Columbia.

- 5.) Ozark A Champs event review- Mark Imig: The information was sent to Beth Paskoff today. Zones went well. Warm-ups were staggered after the first day and athletes had better swims. Next year a dinner will be set up the night before Zones.
- 6.) SAA Presentation-Jimmy Tierney: Swim Across America is a non-profit organization. IT is to raise money and awareness through swimming for those with cancer. It was started in 1989 and there are 15 sites in the United States. Over 65 million dollars have been raised so far. At the 27 August 2016 swim in St. Louis, there were over 200 swimmers and they raised over 65 thousand dollars. - 7.) Clinics- Derek Shipp: EDWY ran a regional coaches clinic last year. It is difficult for coaches to take off work and be gone for an entire week. American Swim Coaches Association now provides online access to clinics and thousands of talks. It would be \$80 per coach to register. The club team for each coach would pay for this cost. \$2500 per year for Ozark to register. Can

complete ASCA level 2 and 3. We can track usage. Jason motioned for Ozark to pay for online access for Ozark coaches, Dave second, approved. Derek will advertise this service to coaches and get the system launched.
