a) May Elections

b) LEAP

c) USA National Workshop

- i) Sept will now be the Annual Business Meeting All virtual

d) USAS Insurance

- i) When renting pools teams have to have a certificate of insurance.
- ii) The process for getting insurance has changed.

e) Officials – Andy Allman

- Andy will be bringing a proposal to the May meeting that will help create an incentive for more people to become officials.
- ii) Pre-Covid we had around 220 officials, but currently have approximately 180.
- iii) Teams are currently paying to register officials so there's not much incentive to recruit more officials because of the cost, especially for larger teams.
- iv) Andy is planning to propose an increase in Ozark surcharge fees from \$2 to \$3 to pay for officials, and to increase splash fees from 8% to 12% to decrease team burden.
 - a. Discussion: Tom Lombardo stated that 20% of 200 officials do all the meets, the rest only show up occasionally. If Andy's proposal goes through then teams should put some requirements on officials to work a certain number of meets; not necessarily their own.
 - b. Andy is open to ideas.

f) Athlete Reps

- i) We are in need of athlete reps for the board.
- ii) They need to be 16 or a high school Sophomore.
- iii) Asking for everyone to submit names in the next 30 days, or at the Senior Champs meet if you have one by then.
- iv) Athlete term is 2 years on the board.

g) Relay charges

- i) Mark Imig feels some teams are charging too much for their relay fees. Some teams, including Champs fees, are \$20.
 - a. Discussion: Bob Rettle made the point that if we charge less for relays then teams will make up the difference in their surcharge. Ozark would then get less in splash fees but we won't get a higher percentage of the surcharge either. It's better for Ozark for the event fee to be higher rather than the surcharge.

h) Meet Information

- i) Sean Harrison stated that teams need to get their meet information posted in a more timely manner so other teams can plan for the season.
