- Jason Owen discussed an study on adolescent athlete nutrition that is looking for participants. He will pass along information as he gets it.
- Mark Imig has the Ozark Hall of Fame nomination form on the Ozark website. New Hall of Fame members will be announced at LC Champs.
- Terea Goodwin discussed that St. Louis will be one of the visiting cities for International Swimming Safety day, May 15. USA Swimming will try to send olympians to this event. More information will be coming soon.
- Angie Dorsey discussed using a QR code to present on the scoreboards that links to a PowerPoint with information about volunteering on Ozark committees.
