 - b. Diversity and Hall of Fame line items have been largely unused in last 6 yrs.
 - c. Ideally proposals should be brought by committees and then can be added to budget as approved; more intentional budget with committee input.

- iii. A new rule is expected to be approved by FINA and accepted by USA regarding the use of wetsuits, making them mandatory when the temperature is <20 C, and prohibiting them when the temp is >20 C.
- iv. Right now Zones Champs use FINA age rule; open water committee looking to change that to age on the race date.
- v. Nationals April 3-5, 2020; location decided around Oct.
- vi. Big discussion about USA Swimming not posting in a timely manner how Junior National swimmers are chosen. Still waiting to figure that out.

 - i. Concussion protocol required by officials (all non-athletes).
 - ii. Committee meeting held Sept 4
 - 1. Amended guidelines for advancing through ranks.
 - a. Biggest change Can make Meet ref as soon as 3 years v 5
 - iii. Nov 14 next meeting
 - 1. Will discuss recruiting.
- j. Safety & Sport: Diana Rosen
 - i. Three athletes on Safe Sport Committee.
 - ii. Needs one more adult for Committee.
 - iii. Every team is supposed to have Safe Sport Rep (Not a coach but must be Non-Athlete Member) and Athlete Liaison.
 - iv. By 2021 every team will have to do Safe Sport Recognition
 - 1. If you have parent meeting and discuss Safe Sport then it will count as Parent/athlete education.
 - 2. Encouraged that we do Safe Sport Info at our championship meets (table with SS info).
 - v. No communication between 8 PM and 8 am even if parents are looped in. This includes team emails from the website if there are athlete emails involved.

- i. High school times does not need Form C; only needs to know if there is a relay lead off time that needs to be included.
- ii. Intermediate times (splits) need to be added to the meet database in order for the split to count in SWIMS (ie 1000 being swum during the 1650)

 - i. USA sent out a more streamlined template, which means we had to start over.
 - ii. Trying to keep things as close to previous as before.
 - iii. Board is too large as written by our bylaws; small board is recommended.
 - iv. Who defines fees should be our HOD.
 - v. Admin Board of Review in our bylaws as optional; can be scratched from bylaws.
 - vi. Nominating Committee and Governance Committee (required) do we want to have both?
 - vii. New bylaws have to be approved by end of year; meeting is required because we can't do it by email; Andy proposes we do it by conference call in about a month after everyone has a chance to read through it.
 - c. Convention Reimbursement policy
 - i. Travel policy is outdated and doesn't cover all of travel.
 - ii. Simple, all-encompassing policy is needed.
 - iii. An activity authorized by OZ needs to have expenses covered.
 - iv. Recommend using Government per diem (GSA) which can be preplanned.
 - v. BOD can vote a temp policy until HOD can vote on a permanent policy.
 - d. Registration/Sanction/Meet fee payment changes
 - i. We have the capability to do all of this electronically.
 - ii. \$40/month fee for LSC
 - iii. Clubs will need to be updated on the website.
 - iv. Andy proposed that Gussie, Angie, Trish and Andy get together to discuss how to make it happen.
