



Becoming a Stroke & Turn Junior Official

Prerequisites

- Age 16-17

Steps Needed to Complete Your Training

You must first register as a member of USA Swimming. Until you have done so, you will not be allowed to begin your on-deck training. The next two sections explain how to register.

Register as a Junior Official

- If you want to register as both an athlete and a Junior Official, you will register in the athlete category as both a Premium Athlete and a Junior Official; if you only want to officiate and not swim, you will still register in the athlete category but only as a Junior Official.
 - The fee for Registration is \$84. If you have already registered as an athlete, the fee is \$14.
 - Registration after September 1 of the current year is good through December 31 of the following year.
 - Registration in the Junior Official category is required prior to beginning your on-deck training.
 - Registration allows tracking of various requirements including *Safe Sport for Youth Athletes (13-17)* training, *Concussion Protocol Training*, and the required officials' tests.
- Registration Process:
 - Must be completed prior to starting your on-deck training and must be done to receive an apprentice training card.
 - If you are associated with a club, check with your club registrar to get a registration link. Your club registrar should be able to provide you with any needed assistance to get you through the registration process.
 - If you are not associated with a club, reach out to registrar@ozarkswimming.com to request a registration link.

USA Swimming registration as a Junior Official is not complete until you have completed both *Safe Sport for Youth Athletes (13-17)* training and *Concussion Protocol Training*. Both of these items must be completed in order for your membership to be in good standing and to be allowed on-deck to train.

Complete *Safe Sport for Youth Athletes (13-17)* training and *Concussion Protocol Training (CPT)* (see Appendix for a more detailed explanation of the following steps)

- Log on to your USA Swimming account.
- Click on the “Education – Course Catalog” tab
- Select “Athletes” and then “All” in the window that opens and complete the following item:
 - *Safe Sport for Youth Athletes (13-17)*. The results will automatically associate with your membership, but they may take up to 24 hours to update.
- Select “Officials” and then “Membership Requirements” in the window that opens and complete the following item:
 - *Concussion Protocol Training*. Select either the NFHS Course or the CDC Course (your choice). Once finished, you will receive a completion certificate that must be submitted [HERE](#).

Next, you need to take two online courses that are on the USA Swimming website. The first course, *Foundations of Officiating*, will introduce you to the philosophy of officiating and the expectations of officials at a swim meet. The second course, *Stroke & Turn Judge Certification*, will familiarize you with the technical rules for the strokes and relays that you will be observing on deck. The latter course also has an integrated assessment to test your knowledge. By viewing these courses prior to your on-deck training, you will be in the best position to make the most of your on-deck training.

Complete the on-line USA Swimming *Foundations of Officiating* course and the online USA Swimming Stroke and Turn Judge Clinic and pass the accompanying test (see Appendix for a more detailed explanation of the following steps)

- Log on to your USA Swimming account.
- Click on the “Education – Course Catalog” tab
- Select “Officials” and then “Certification” in the window that opens.
- Complete the “*Foundations of Officiating*” course
- Complete the “*Stroke and Turn Judge Certification Course (Certification Course and Assessment)*” that includes an integrated test.

Before starting your on-deck training, you need to obtain an apprentice training card to record the completion of each of the individual requirements for becoming a Stroke and Turn Junior Official as well as to track the progress of your on-deck apprentice sessions. You will need to bring this training card with you to your training sessions so that the progress of your training can be recorded.

Obtain a Stroke and Turn Junior Official apprentice training card

- Contact Bill Rener (billrener@gmail.com) to request your Stroke and Turn Judge apprentice training card.

The **final steps** in your training to become a certified Stroke and Turn Judge are to complete your on-deck training and then to then submit your training card to Bill Rener who will finalize the certification in OTS.

On-Deck Apprentice Sessions

- Complete 4 on-deck training sessions with a basic understanding of each required skill.
- An apprentice may voluntarily request additional training sessions if the apprentice feels that he/she needs additional training to master the required skills.
- If the validating Meet Referee does not believe the apprentice is ready to be certified and the apprentice does not voluntarily agree to additional training sessions, the Meet Referee must provide the Ozark Officials Chair (Jeff McCoskey) and Bill Rener (Officials Coordinator) with specific deficiencies that need to be remedied, and they will provide the apprentice with a written action plan of the steps needed to successfully obtain certification.

Following Completion of All Off- and On-Deck Training Requirements

- Make a copy of your completed training card and email it to Bill Rener.
- If all certification requirements are met, and barring any rare and unusual circumstances, your certification will be entered into OTS.

What Happens When You Turn 18 Years Old

- Certification is for a 3-year period, which means that you will turn 18 years old prior to your certification expiring.
- On your 18th birthday, you will automatically be switched to the Official registration category and your certification will be switched from Stroke and Turn Junior Official to Stroke and Turn Official.
- Your registration will show “not in good standing” because you cannot complete a background check before your 18th birthday and because you will not have yet taken Athlete Protection Training (APT).
- You will need to complete both a Background Check and APT before you are again in good standing.
- Time, meets, and sessions worked as a Stroke and Turn Junior Official will count toward your recertification as a Stroke & Turn Official.

Steps Needed to Recertify as a Stroke and Turn Judge

- Work a minimum of 8 sessions within a 3-year period at a minimum of 2 different meets as a Stroke and Turn Judge or a higher capacity.
- Attend a clinic every 3 years.
- Pass USA Swimming recertification test every 3 years for the highest certification held.
- Satisfactory performance.

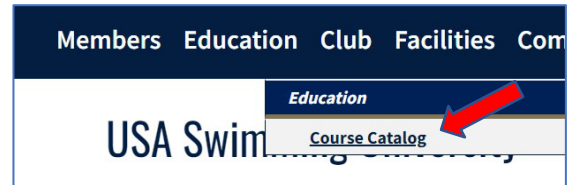
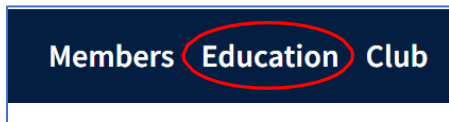

APPENDIX

Instructions for Completing Membership, Educational, and Testing Requirements for Junior Officials

1. Log into your account on the USA Swimming website.
2. Click the Education tab and select Course Catalog



3. In the window that opens, select Athletes → All to access SafeSport For Youth Athletes (13-17).

4. The required course will be visible. Once you complete the course, take a screen shot of the certificate or the final screen that includes the date of completion. This will be helpful if the course fails to update in your record. Completion of the course will automatically update in your record, but it may up to 24 hours. If it doesn't match after that, please contact registrar@ozarkswimming.com for assistance. That will be the most efficient and effective way to get assistance.



5. While in the Course Catalog, select **Officials** → **Membership Requirements** to access Concussion Protocol Training.

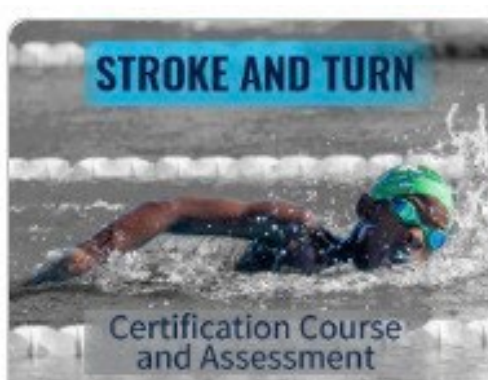
