General Meeting:	The General Meeting will be held virtually on Thursday, February 22nd, 2024, via Zoom at 6:30 PM. It will be recorded and posted on the host's website. Additional coaches' meetings may be held as determined by the Meet Referee. It is the responsibility and obligation of each team or unattached swimmer to be represented at all coaches' meetings. Coaches or other team representatives are responsible for all information presented at these meetings including changes to the meet format or conduct. Coaches should check their team mailboxes prior to each session and look for postings where they pick up heat sheets.
Facility:	Two Eight-Lane, 25Y pools with non-turbulent lane markers and backstroke flags. Pool Depth at North Pool starting end is 7'. Pool Depth at South Pool starting end is 16'. Minimum of 6'10" at both turn ends. Block height is 29.5". The meet host will ensure the required course dimensions are met. The pool uses a fully automatic Superior Swim Timing system with a full video display board, beep starts, and touch pads on the starting end of the pool. Backstroke starting wedges will be available. Two buttons and two stopwatches will be used for back-up times.
Scratch Table:	All scratches, including scratches for finals, will be done online. More information will be presented at the coaches meeting and on the Meet Landing Page.
Deck Access:	Deck access is restricted to participating athletes, coaches, working officials and other meet personnel (marshals, timers, etc.) Authorized personnel will be issued a credential tag which must be displayed at all times when on pool deck. Coaches must be in good standing and show proof of current membership prior to the start of each session. The official mobile application of USA Swimming should be used for proof of USA Swimming membership.
Spectator Admission:	No admission will be charged. Heat sheets will be available for free on the meet landing page and Meet Mobile. Restrooms are available in the east hallway. Handicapped seating is on deck. View may be obstructed by coaches, officials, and athletes.
Parking:	Parking is available in the east and west lots at WSAC for a \$5 fee. Additionally free parking is available behind the store fronts on Green Bay Road with a short walk across a footbridge. Do not park behind Pick & Save or on the side of the Sprint Store or in front of store fronts.

- Concessions: A superb selection of food and beverages will always be available during the meet.
- Lost and Found: Please check the lost and found area, near the office. The facility and the meet host are not responsible for lost items. Items not picked up by the end of the meet will be discarded or donated.

RULES AND PROCEDURES

- Official Rules: Official Current USA Swimming and Wisconsin LSC rules shall prevail for this meet except as otherwise specified in this meet information. Swimmers must be registered USA Swimming athletes. Deck registrations are not allowed. Athlete age will be determined as of February 23, 2024. All Coaches and Officials are required to check in and prove that their USA Swimming Membership is in Good Standing. The official mobile application of USA Swimming is acceptable proof of USA Swimming membership.
- Para Athletes: Para athletes or their representative coach will be expected to provide a written document of the desired accommodations (physical needs maneuvering throughout the venue) and modifications (technical rule changes while swimming) to the meet referee upon arrival. Failure to provide documentation will grant the meet referee complete discretion towards disqualifications, with no protest. Request forms may be found on the [WSI website](#).
- MAAPP Acknowledgement: All applicable adults participating or associated with the respective meet to which this information applies, acknowledge that they are an applicable adult, subject to the provisions of USA Swimming's MAAPP, and that they understand that compliance with the MAAPP Policy is a condition of participation in the conduct of this competition. Times achieved by an athlete member at a sanctioned/approved meet who is 18 years of age or older, who had not completed the Athlete Protection Training (or whose APT training had expired) by the date of the swim, will not be able to be uploaded to SWIMS.
- Start Certification: Any swimmer entered in the meet must be certified by a USA Swimming member coach as being proficient in performing a racing start or must start each race from within the water. Further, those participants not proficient with a backstroke ledge may not use the backstroke ledge. When unaccompanied by a member-coach, it is the responsibility of the swimmer or the swimmer's legal guardian to ensure compliance with this requirement.
- Protests: For consideration of all protests lodged at the meet, the Meet Referee may appoint a meet jury. The jury shall consist of not fewer than three (3) and not more than five (5) persons, at least one of whom shall be a coach and one an athlete.
- Video and Photo: All participants agree to be filmed and photographed by the official photographer(s) and network(s) of Wisconsin Swimming and the meet host under the conditions authored by Wisconsin and USA Swimming, and allow event organizers the right to use names, pictures, likenesses, and biographical information before, during or after the period of participation in this Wisconsin Swimming competition to promote such competitions.
- Conduct: All coaches are responsible for the conduct of their swimmers and will see that their club has proper supervision at all times. Meet Marshals have the authority to remove any swimmer and/or spectator from the meet for any violation such as improper behavior, damage to property, etc. No smoking on the premises. Please encourage your parents and swimmers to clean up after themselves.
- Use of audio or visual recording devices, including cell phones, is not permitted in the changing areas, restrooms, or locker rooms.
- Changing into or out of swimsuits other than in locker rooms or other designated areas is not appropriate and is prohibited. Deck changes are prohibited.
- Operation of a drone, or any other flying apparatus, is prohibited over the venue (pools, athlete/coach areas, spectator areas and open ceiling locker rooms) any time athletes, coaches, officials and/or spectators are present.
- First Aid Report injuries to the lifeguard staff and Meet Director. Please contact the lifeguard on duty for first aid supplies. An AED is available on site. EMS can be contacted if needed via the lifeguard on duty.

OFFICIALS INFORMATION

- Officials Meetings: Officials Meetings will be held 60 minutes before the start time of each session in Hospitality.
- Timer's Meeting: Timer's Meetings will be held 30 minutes before the start time of each session.
- Officials Qualifying Meet: This meet will be submitted for designation as an "Officials Qualifying Meet," for certification and recertification evaluations for N2- and N3-level positions. Evaluations can be requested on the application to officiate form on the meet landing page. Opportunities for evaluations may be limited by time and personnel resources. Availability of final evaluations for N-3 may be provided at the discretion of USAS Officials Committee designation of the meet.
- Application to Officiate: Please check the Meet Landing Page for the application to officiate.
- Questions: Please contact the Team Lead CJ with questions or concerns about assignments and/or availability.

WARM-UP AND MEET SCHEDULE

- Prelim Warm-up: Friday-Sunday Prelim warm-ups start at 7:00AM with meet starting at 8:35AM. Depending on size of meet and timeline, these warm-up times may be adjusted by meet management and teams will be notified.
- FINALS: Friday-Sunday Finals: Warmups start at 4:00 PM with the meet not starting before 5:05 PM. Dependent on timelines - the Finals timeline may be adjusted, and teams will be notified.
- Pre-Session Warm-up: Warm up times and lanes for prelims will be assigned unless otherwise noted. Assignments will be posted on the meet landing page and communicated to the "lead" coach for each team.
- Circle swimming only, entry into the water shall be feet first three-point entry for all competition, except in designated lanes and times. All entry to pools during open warm-up cool down periods must be from the start end. Teams should plan to do starts, sprint and pace work within their assigned warm-up time. No snorkels, kickboards or other training devices are allowed during warm-ups.
- Swimmer(s) without a coach present are to report to the Meet Director prior to warm-ups for lane assignment.
- In-Meet Warm-up: The South Pool will be available for warm-ups throughout the competition.

ENTRY INTO THE MEET

- Swimmer Eligibility: All swimmers must be registered athlete members of USA Swimming and Wisconsin Swimming, and be in good standing. All individual swimmers entered in the meet shall be eligible to swim in the meet, having at least one verifiable qualifying time. Swimmers who cannot verify qualification for the meet with a proof of time will be withdrawn from the meet. Any swimmer who swims in the meet and is found ineligible will be disqualified from the meet, forfeit all awards and points achieved and their club fined \$200. There will be no deck entries or registration. The representative submitting entries shall be responsible for verifying that all swimmers satisfy these requirements.
- Qualifying Times: **QUALIFYING TIMES MUST BE ACHIEVED AFTER SEPTEMBER 1ST, 2021.** Qualifying time standards can be found on www.wisconsinswimming.org - under Events - Championship Meets. Qualifying times will be accepted in Short Course Yards, Short Course Meters, or Long Course Meters.
- Seeding: Non-conforming times will be seeded after SCY times. The order used for seeding will be SCY-SCM-LCM. Bonus entries will be seeded after qualified swims in the same order.
- Para Athletes: Swimmers may enter any event (up to the limit of the meet information) but they must have achieved a Wisconsin Swimming State Time Standard OR the Disability Para Motivational Championship Time Standards (P1, P2, P3). Both sets of time standards can be found on Wisconsin Swimming's website (www.wisconsinswimming.org) Although swimmers with disabilities can enter any event(s) the only events that will be scored and awarded in Para categories are noted on the event page.

When entering an athlete with a disability to the designated Disability events or any other events, email the Entry Chair so they can be verified and seeded properly. If coaches have any questions regarding the Disability inclusion at the State Championship, please email Wisconsin Swimming's Disability Chair, Tom Miazga - tommiazga8@gmail.com. Information can be found on the Wisconsin Website (www.wisconsinsswimming.org).

Meet Management may combine entries based on gender and/or age groups.

USA Swimming defines a Disability as a permanent life affecting impairment/disability. This would include everything from a club foot through to children on the spectrum where it affects their reaction times, severe learning disabilities, etc and everything in between. The two key components are that it must be permanent (recovery from surgery, a bad sprain, etc is not acceptable) and it must affect their performance.

Age Groups: There will be one age group – designated as Senior.

Entry Limits: A swimmer may compete in not more than six (6) individual events total for the meet, limited to three (3) individual events per day, excluding time trials events. Athletes can enter any/all qualifying events but must scratch down to 3/day and 6/Meet. A swimmer may compete in no more than three (3) individual events per day including time trial events. Time trials are under a separate sanction and therefore DO NOT fall under the six (6) events for the meet but DO fall under the total of three (3) events per day as mandated by USA Swimming.

Bonus Events: Any swimmer who has entered with one qualifying time may enter three bonus events for which they do not have a qualifying time. Any swimmer entered with two qualifying times may enter two bonus events and any swimmer entered with three qualifying times may enter one bonus event.

Relay Events: All relay events will consist of A/B relays. The 200 Yard, 400 Yard, and 800 Yard Events.

A Relays must consist of at least two (2) individual qualifiers. These relays may include up to 2 relay-only swimmers as needed.

B Relays – eight (8) individual qualifiers.

Downseeding will be allowed for the 800 Yard Relays.

Relay-only swimmers must be included in your entry. To add a relay-only swimmer after the entry deadline, the swimmer must be entered in the meet 30-minutes prior to the start of the session in which they will swim.

\$18.00 Facility Surcharge
\$28.00 Per athlete admission surcharge (Heat Sheets will be posted on Meet Host Landing Page.) No admission will be charged to the meet.

Entry Procedure:

- **INITIAL ENTRY DEADLINE:** Entries are due Monday, February 19th at 10:00 PM. Submit entries with Hy-Tek Entry File. ENTRIES MUST INCLUDE A PDF COPY OF ENTRIES INDICATING ALL BONUS EVENTS. Please also include known required proof of time documentation with entry. Email entry files and hard copies to lakecountryswim@sbcglobal.net.
- **ENTRY FOR 50Y OF STROKE AND 100 IM:** 50-yard of stroke events (Backstroke, Breaststroke and Butterfly) MUST enter with a qualifying 100Y Time – ENTER AT 100Y TIME. 100-yard IM MUST enter with a qualifying 200Y IM Time – ENTER AT 200Y TIME.
- **LATE ENTRY DEADLINE:** Entries received after the deadline may be accepted upon remittance of a \$100 late fee. Entries submitted after 6:00 PM on Tuesday, February 20th, 2024, will not be accepted.

- **PROOF OF TIME DEADLINE:** All entry times will be verified against the SWIMS database, if you use override (custom) times, you must provide all proof of times by Wednesday February 21st, 2024, at 3:00 PM. After that point, all “unproven” times may be scratched from the meet. Entry times requiring proof will be posted on Tuesday, February 20th. Submit printed proof of time on PDF with time highlighted or otherwise designated.

Acceptable proof of time includes the USA Swimming SWIMS database and printed, or viewable Meet Final Results from any USA Swimming sanctioned, approved, or observed meets, high school meets, YMCA closed competition, and NCAA closed competition. Acceptable proof of time identifies the swimmer by name, his/her time, and the meet name and the date on which the swimmer previously achieved the qualifying time. High school meets include any season ending meet (Conference, Sectional, State Championship).

- **PSYCH SHEETS:** Psych Sheet WILL NOT be posted until Wednesday, February 21st, 2024. Only changes for administrative errors are allowed after the Psych sheet is posted.
- **PAYMENT:** A non-refundable check for entry fees and surcharges must be received before the start of the meet. All payments will be made via check or cash, no credit cards will be accepted. All express mail must be pre-signed, so it will not require a signature for delivery. **Make checks payable to Lake Country Swim Team.**
- **PARA-ATHLETE ENTRY:** When entering a para-athlete into the meet, please be sure to include any needed documentation used to determine P1, P2 or P3 designated disability placement. If coaches have any questions regarding the Disability inclusion at the State Championship, please email Wisconsin Swimming’s Disability Chair (Tom Miazga - tommiazga8@gmail.com)

CONDUCT OF THE MEET

Format:	The meet will be a combination of prelim/final events and timed final events. Flyover starts will be used in prelims. Swimmers will report to the blocks for prelims.
Breaks:	Breaks may be inserted and removed at the discretion of meet management. The duration of each break will be determined by meet management. The competition pool may or may not be open for warm-ups during these breaks.
Finals:	The top 32 of each gender for Senior events will advance to finals in prelim/final events with a protected D Finals (16Y and younger athletes). Swimmers in the Championship Final should report to the staging area in front of the meet management office to parade to the starting blocks. These procedures will be clearly explained at the coaches’ meeting.
Timed Finals:	The following individual events will be conducted as timed finals with the top heat competing in finals: 400 IM, 500, 1000 and 1650 Free.
Relays:	All relays are timed finals. 400 Y relays will be swum at the start of prelims, 200 Y relays will be swum at the start of finals. The 800 Y free relay will be split between prelims and finals, with the top heat competing in finals and all other heats competing in prelims, fast to slow alternating genders.
Disability Event Finals:	Designated Disability Event Finals will be completed in a separate heat, combined by classification and gender, but separated for scoring and awards. These events will take place between the female and male sections of the corresponding event.

SCRATCHING AND DOWNSEEDING

Scratch from Prelims:	Swimmers may scratch from an event in which they are entered by submitting a scratch form. The “scratch box” will be online for this meet. Information about the online scratch box will be communicated to coaches and available on the meet landing page.
	Swimmers may scratch from an event in which they are entered by following the procedures set forth in the meet announcement.

In all events where preliminary heats are necessary or in any timed final event, after the heats have been seeded, any swimmer who fails to compete in an individual event heat in which such swimmer entered and has not been scratched in accordance with above will be barred from all further individual and relay events of that day.

The application of this penalty shall pertain to the order in which the event/heats are swum, not the numerical order of the events. Additionally, that swimmer shall not be seeded in any individual events on succeeding days unless that swimmer declares an intent to swim prior to the close of the scratch box for that day's events.

No penalty shall apply for failure to withdraw or compete in the Prelims or Timed Finals heat of an individual or relay event if the swimmer or coach notifies the Administrative Referee or the Deck Referee prior to the swimmer's assigned heat of a Declared False Start.

Scratch Deadlines: Friday Events 30 minutes after the coaches meeting on Thursday.
Saturday Events Friday by 6:00 PM
Sunday Events Saturday by 6:00 PM

Down-Seeding: Down-seeding will only be allowed for Individual distance events (400 IM, 500Y, 1000Y and 1650Y freestyle) and 800Y Relays events. Down-seeding must be declared by the scratch deadline for that event. Down-seeding procedures will be announced at the general meeting.

Declared False Starts: A DFS can be made by the coach or swimmer to the Administrative Referee or Deck Referee at any time prior to the start of a heat in which the swimmer is seeded, or failed to scratch, during the preliminary sessions. During warm-ups (prior to the start of the session), the DFS is given to the Administrative Referee in the glass office. After the start of the session, the DFS is given to the Deck Referee.

A DFS may be made in a Timed Finals event and for swimmers in the fastest heat swimming with Finals in a Timed Finals event. No explanation for the DFS is required, and all requests shall be granted. A DFS is a disqualification for the swimmer and counts towards the total allowed events per day and per meet.

DFS is not allowed in Finals. If a swimmer fails to compete in finals (except due to injury, illness or circumstances beyond the control of the swimmer, as determined by the Meet Referee), it is a failure to compete, and the swimmer is barred from the remainder of the meet.

Relays: A relay team member failing to appear ready to swim for the relay event shall be barred from the next individual event in which the swimmer is entered, on that day or the next meet day, whichever is first. The relay team members who do appear ready to swim shall not be penalized for failure of the other team members to appear.

Scratching Timed Finals Events in Finals:

Scratches from Timed Finals events, that are unseeded, must meet the scratch deadline. For seeded Finals see the DFS rules above. Scratches, from seeded time final events with heats competed during Finals shall be made directly with the Administrative Referee.

NOTE: After an event has been seeded, do not use the online scratch process to scratch from timed finals heats competed during Finals.

Scratch from Finals: After the preliminary heats have swum, results will be announced. After announcing is complete swimmers will have thirty (30) minutes to scratch or declare their intentions to scratch. Once events close there is no scratching from finals.

Failure to Compete: Any swimmer qualifying for a Finals race in an individual event who fails to compete in said race shall be barred from further competition for the remainder of the meet. Disqualification under this section shall apply only to swimmers qualifying based on the original preliminary results. However, if a swimmer or coach is notified that the swimmer has scratched into a Finals race in an individual event, accepts the position, and then fails to compete, the swimmer shall be barred from further competition for the remainder of the meet.

In the event of withdrawal or barring of a swimmer from competition, the Meet Referee shall fill the Consolation Final or Championship Final, when possible, with the next qualified swimmer(s). First and second alternates shall be announced along with the Final qualifiers. These alternates shall not be penalized if not available to compete in Finals.

When Consolation Finals have not yet been swum and a barring or withdrawal is known to the Meet Referee, the Meet Referee shall reseed the Consolation Final and Championship Final, if necessary, by inserting the alternate(s) in the appropriate lane(s), filling all lanes in the Championship Final race. If a Consolation Final has been contested, the Championship Final shall be swum without reseeding for empty lanes.

Finals Check-in procedure will be discussed at the coaches meeting.

No penalty shall apply for failure to withdraw or compete in an individual event if:

1. The Meet Referee is notified in the event of illness or injury and accepts the proof thereof.
2. Bonus, Consolation, or Championship Final based upon the results of the preliminaries notifies the referee within thirty (30) minutes after the announcement of the qualifiers for that race that they will not compete.
3. A swimmer qualifying for a Bonus, Consolation, or Championship Final race based upon the results of the preliminaries notifies the Administrative Referee within thirty (30) minutes after announcement of the qualifiers for that race that they may not intend to compete and further declares their final intentions within thirty (30) minutes following their last individual preliminary event.
4. It is determined by the Meet Referee that failure to compete is caused by circumstances beyond the control of the swimmer.

AWARDS AND SCORING

Awards:	Individual Events: Medals for 1 st to 8 th Place. Ribbons for 9 th to 16 th Place Designated Disability Events: Medals for 1 st to 3 rd place in each category. Relays: Medals for 1 st to 3 rd Place. Ribbons for 4 th to 8 th Place. Individual High Point: 1 st to 3 rd Place for each gender and age group. Team Champions: The LSC will provide an award for the overall 1 st place team in each of the three divisions. 2 nd and 3 rd place team finishers will have an opportunity to purchase awards if they wish. State Champion T-Shirts will be available to all winners (one t-shirt per athlete).
Award Presentations:	Award presentation schedule will be posted and distributed. Awards will be presented on the podiums on the West side of the pool. Staging will take place in front of the meet management office and athletes will parade across the bulkhead to podium.
Scoring:	24-Place Scoring will be used for all events. Relays will score double. <u>Individual Events:</u> 32, 28, 27, 26, 25, 24, 23, 22, 20, 17, 16, 15, 14, 13, 12, 11, 9, 7, 6, 5, 4, 3, 2, 1 <u>Relay Events:</u> DOUBLE OF INDIVIDUAL EVENTS

When:

At the conclusion of Friday, Saturday, and Sunday prelim sessions and Sunday finals session as time permits and **at the discretion of the meet director.**

Events:

All meet events will be offered on Friday-Sunday. Events will be combined where appropriate at the discretion of the meet management.

PLEASE NOTE: Time trials for 1000Y free and 1650Y free are only offered in open lanes during the heats of those events in the meet. These distance events will NOT be offered at any other time.

Eligibility:

Open to swimmers entered in the 2024 Senior State SCY Championship Meet. The maximum number of individual events in one day is three (3), time trials and individual events combined.

Fee:

\$15.00/individual event and \$25.00/relay event.

Registration:

Registration will be accepted during the prelim and final sessions. The Administrative Team will set up registration guidelines for signing up. The registration deadline for each time trial session will be posted and announced. Payment is due at the time of registration.

Procedures:

Swimmer(s) will sign up for time trials online (Administrative Team will have QR codes posted for Time Trial Sign-Up). A schedule of the closing times for time trial registration will be posted dependent on timelines.

A meeting for all time trial participants and timers will be held prior to the start of Time Trials.

Heat Sheets for time trials will be posted and distributed when they are ready.

It is the swimmer's responsibility to be ready to swim when his/her event, name, and lane number are called.

The Referee will not hold the start of the event waiting for a swimmer (or timer) to show.

ALL time trial results must be recorded on provided forms.
